COMMITTAL ORDER UNDER SECTION 209 OF Cr.P.C

The RFO, Somwarpet has filed charge sheet against accused No.1 to 3 for the offences punishable under Sections 62, 80, 86, 87 of Karnataka Forest Act, 1963 and Rules 154, 155 and 165 of the Karnataka Forest Rules, 1969.

2. After filing of charge sheet, cognizance is taken for the offences punishable under Sections 62, 80, 86, 87 of Karnataka Forest Act, 1963 and Rules 154, 155 and 165 of the Karnataka Forest Rules, 1969. Registered criminal proceedings against the accused No.1 to 3. The accused No.1 is obtained Anticipatory bail Hon'ble Ist Addl.District & Session Judge, Kodagu at Madikeri, in CrI.Misc.No.375/2024, dt.15.10.2024, accused No.2 is obtained Anticipatory bail Hon'ble Ist Addl.District & Session Judge, Kodagu at Madikeri, in CrI.Misc.No.435/2024, dated 20.11.2024, and accused No.3 obtained Anticipatory bail Hon'ble PrI.District & Session Judge, Kodagu at Madikeri, in CrI.Misc.No.453/2024, and also the obtained a regular bail before this Court. Subsequently accused No.1 to 3 are continuously

absent and court issued a NBW against the accused No.1 to 3 on.07.05.2026, RFO Somwarpet police NBW executed against the accused No.1 and this court remanded to the JC. Further accused No.1 not furnished committal surety and the copies of charge sheet and its enclosures furnished to the Sri.HRP counsel for accused No.1 as contemplated under Section 207 of Cr.PC. Accused No.2 & 3 continuously absent, hence, split up charge sheet filed against the accused No.2 & 3 and same split CC number registered as 348/2026.

3. On perusal of materials on record, it appears that the offence punishable under Section 62, 80, 86, 87 of Karnataka Forest Act, 1963 and Rules 154, 155 and 165 of the Karnataka Forest Rules, 1969, and section 86 & 87 is exclusively triable by the Hon'ble Prl. District and Sessions Judge, Kodagu at Madikeri, Therefore, the case has to be committed to the said court for trial. Accordingly, I proceed to pass the following :

ORDER

Acting under Sec.209 of Cr.P.C, the case is committed to the Hon'ble Prl. District and Sessions Judge, Kodagu at Madikeri, for further proceedings on the following :

CONDITIONS

1. Accused No.1 is remanded back to J.C. during and until conclusion of the trial.
2. The respective Jail authorities are hereby directed to produce the accused No.1 before the Hon'ble Prl. District and Sessions Judge, Kodagu at Madikeri, as and when the Hon'ble Court directs to do so.
3. Office is hereby directed to submit entire case file along with properties and other properties if any, to the Hon'ble Prl. District and Sessions Judge, Kodagu at Madikeri.
4. Somwarpet RFO is hereby directed to submit properties if any, to the Hon'ble Prl. District and Sessions Judge, Kodagu-Madikeri.
5. Notify the Public Prosecutor regarding the commitment of this case to the Hon'ble Prl. District and Sessions Judge, Kodagu at Madikeri.
6. The bail bond executed by the accused No.1 shall be executable before committal court.
