Heard. For the reasons stated in application, application is allowed. Accused Ibrahim Khan and Avik Kedia are exempted from their personal appearance only for today.

Counsel for accused Abhishek Mansa has placed on record internet copy of order dated 20.02.2023 of Hon'ble Supreme Court of India in WP (crl) No. 522/2022 according to which present FIR No. 141/2021 PS Special Cell qua accused Anas Ahmad has been transferred to Dehradun Court. It is further stated by Counsel for accused Abhishek that he is in the process of moving before Hon'ble Supreme Court of India qua accused Anas Ahmad in this regard.

As per present chargesheet, Anas Ahmad is not accused in the present FIR No. 141/21, PS Special Cell. Let report be called from the IO with respect to status of Anas Ahmad in FIR No. 141/21, PS Special Cell returnable on NDOH.

It is stated by all the accused persons except accused Rajni Kohli that they have received copy of all the documents, therefore, scrutiny of documents is complete qua accused persons except accused Rajni Kohli.

An application u/s 207 CrPC is filed on behalf of accused Rajni Kohli. Copy supplied to Naib Court, PS Special Cell.

Let IO be summoned for supplying deficient documents to accused Rajni returnable on NDOH.

Put up for arguments on charge on **10.07.2023**. Rehnumai of accused persons through VC on 01.05.2023, 15.05.2023, 29.05.2023, 12.06.2023 and 26.06.2023.
