Examination-in-chief by Public Prosecutor:

1. PW.1 is my husband. Deceased Chittiyappa is my father in law, the accused now produced through VC is my brother in law. My father in law is having four children. My husband is elder one, second one is Subramani/CW.14 and Poovaiah CW.13. CW.13 residing at Bengaluru, CW.14 residing at Balele Village.

2. Accused is a last son, he resides with my husband and my father in law in family house. Accused is unmarried. He was not working, he is habit of consuming alcohol and making quarrel with my father in law.
3. On 13.02.2022, the accused assaulted my father in law on his face and caused injuries, for which my father in law had filed criminal case against accused. Later on the said case was compromised with the accused. Even after compromised the accused continue to quarrel with his father demanding money and property.
4. On 18.10.2023 myself and my husband with children had been to Parane Village. My father in law and accused they were in the family house. On same day at 7.00 PM my husband had received phone call from accused stating that 'ತಂದೆಯನ್ನು ಹೊಡೆದಿದ್ದೇನೆ, ನ್ಯಾಯಾಲಯದಲ್ಲಿ ನೋಡಿಕೋ' and disconnected the call. Immediately, after informing me, my husband rushed to Nangala Village house at 8.00 PM

with CW.2 and 3. At 9.45 PM my husband informed me stating that his father has been expired in Virajpet hospital. On next day morning I came to my husband house, I had seen the dead body of my father in law. Now I see the photographs appearing dead body of my father in law at Ex.P.7(series). I have given statement to police. My other brother in laws were also aware of incident.

5. My husband after receipt of phone call from the accused, he had informed to his brothers immediately. My husband did not called neighbours of the village in my presence to go and verify. The relatives of Parane were made known about the incident. My husband alone went to house.

6. On next day I had seen dead body of father in law in Virajpet Government hospital mortuary. The villagers have also come to hospital. I did not see the accused beating his father in the month of February 2022. In

respect of said incident police did not enquired me. It is incorrect to suggest that in respect of property partition there was dispute between my husband and his brothers. I say other brothers are is cordial with my husband, except accused.

7. On 19.10.2022 I did not see the accused in the house when I came from Parane Village. In respect of this case I have not visited police station. In the hospital police were present, I was not enquired and not given statement.
