**Examination-in-chief by Public Prosecutor:**

1. Since 15 years I am staying in Bengaluru. PW.1 is my elder brother, CW.14 is my second brother and the third son of Chettiyappa, accused is the fourth son.
2. PW.1 and 2, deceased were resided along with accused in family house at Nangala Village. Accused addicted to alcohol and demanding money from the father and the quarreling with him. On 13.02.2022 accused assaulted the

father, my father had lost his teeth, his lips were cut. Subsequently, the deceased had compromised with accused.

3. On 18.10.2023 when I was in Bengaluru at around 9.30 PM I received phone call from PW.1 stating that the accused with wooden stick assaulted the father for head and face, caused injuries taken to hospital and he was declared dead.
4. On next day on 9.30 AM I came Virajpet Government hospital mortuary I had seen the dead body of father at 9.45 AM. My father had injuries on his head, forehead, ears, eyebrows, right side cheek swelling, cut marks on face, back and top of the head, right hand injuries with swelling and left hand middle finger cut injury.
5. PW.4, CW.11, 12, 14, PW.1 and 2 and other villagers and relatives were present. In the mortuary police conducted

inquest mahazar and recorded my statement. CW.14 and 15 were also present and gave statements. Now I see the Ex.P.7(series) photos of my father.

**Cross Examination: Sri.VSP(Legal aid) Advocate for accused**

6. On 13.02.2022 I was not in family house. Prior to 9.30 PM I did not received any information regarding incidence on 18.10.2023. 9845864455 is my phone number. PW.3, 4, CW.12, 13 are neighbours and relatives. It is incorrect to suggest that there was a family dispute in respect of properties. It is incorrect to suggest that in respect of family property dispute I am deposing falsely before the court.
