

**Witness recalled and duly sworn on 22.08.2025**

**Cross Examination: Sri.PCK standing counsel for accused**

1. My father was stayed in Nangala village. My brothers are not residing separately. There are other residential houses near at Nangala. Poovaiah brother is residing at Bengaluru, another brother is Subramani is residing at Balele. Accused is a bachelor. Accused was not working. Accused demanding money from father. Accused stayed with me. My father was aged.
2. My father vision was gone. It is not true that accused and father together were residing, I say they were staying with me. It is not true that I stayed in different place and visiting the house of father, I say I was staying with father. It is not true that accused was going for work and used to stay at work place itself. Two days prior to incident I had been to Parane. It is not true that my wife and children are permanently staying in her parents house at Parane. It is

3. not true that my wife staying at Parane sometimes she comes to Nangala village.
  
4. It is not true that on 13.08.2022 the accused has not quarreled with father and not caused any injuries. It is not true that in the properties of father the accused has share. I say father had already given accused share in his properties. Accused has called me with his mobile to my mobile while I was at Parane village. I have not stated the phone number from which my brother has called me in the complaint. The distance between Parane and Nangala is 8 kms. My children were small, they were left at Parane and I alone came to Nangala. After receipt of information through phone immediately I rushed to the house, where the accused has locked the door and he opened the lock after seeing the injuries to the father I filed the complaint. The accused was in the room where father was there when I had entered the house. The accused was in the front room

of the house. It is not true that on that day the accused had gone to work. It is not true that my father is habit of taking drinks at night. My father used to cook food himself with firewood. When I had been to house of father, he was on sofa. He was not in a position to speak, but he was alive. It is not true that MO.1 and 2 are used in the house of firewood, but I say both sticks were used by the father to walk with help of sticks. MO.1 and 2 stained with blood as such with those the accused beaten the father. It is not true that MO.1 and 2 have no nexus to this case.

5. I had informed to other brothers about the information of injuries caused to the father given by the accused. I have stated the said fact in the complaint. When I entered the house neighbours did not come. To save my father immediately I had shifted father to the hospital, as such I did not file complaint before shifting him to hospital. Chottaranda Thammaiah was with me in the hospital.

Typed complaint was given to the Police. Police have enquired me. I was alone when police enquired me. CW.19 and 20 are my relatives. They came to the village after knowing the death of father. It is not true that there is enmity between me and accused in respect of property. There was blood stains in the sofa, the cloths of father and on wall as well as ground in the house. The neighbours were not visiting the house of father. It is not true that police have not collected blood stains in my presence at MO.3 to 7. I have shown the place to the Police. When police came to conduct mahazar by that time the accused was taken by the police.

6. On 18.10.2023 in the night accused was arrested. It is not true MO.1 and 2 were given by me to the Police. It is not true that MO.1 and 2 have no nexus to this case. In Ex.P.3 series photos I am standing as instructed by the police. PW.6, CW.5 and 7 are from my village. They were not in

term with accused. MO.1 and 2 are not bamboo sticks. Around my house there is estate. On the date of incident PW.6, CW.5 and 7 did not inform me about the incident, but on next day they have told me about there witnessing the incident through window. Police seized MO.1 and 2 from the accused room. It is not true that I have not filed any complaint to the Police. It is not true that accused not informed me over phone. It is not true that the accused has no nexus to the death of father. It is not true that father after having drinks, he had no vision, fell on ground and sustained injuries. It is not true that accused has not assaulted the father. It is not true that I have not given any statement to the Police. It is not true that in respect of property dispute I have filed false complaint.
