**Examination-in-chief by Special Public Prosecutor:**

1. I know CW.2 to 18. I know accused present before the Court, she was the member of Gandhi Nagara ward Municipality. I belongs to Schedule Caste (Madiga). Accused belongs to Kodava Caste.

2. On 09.01.2022 myself and CW.2 to 18 making road to cemetery as sanctioned by the town Municipality at Shivakeri. Around 11.30 am, the accused came to the spot, asked me to stop the work and questioned the work

3. order to carry out the work of making road. I told her the municipality has sanctioned work order, accordingly making road. The accused knowing well that I belongs to Madiga caste, abused me stating that ಹೊಲೆಯ ಮಾದಿಗರು ನಿಮಗೆ ಏನೂ ಕೆಲಸ ಮಾಡಿಕೊಡಬಾರದು, ನಿಮ್ಮ ಜಾತಿನೇ ಹೀಗೆ. She humiliated me before the public.

4. Thereafter, I informed to then MLA and asked him to decide the matter and he did not do anything. Accordingly, on 13.01.2022 I have filed a complaint in the police station accompanied by the villagers. Now I see the complaint, marked as **Ex.P.3, 3(a)** is my signature.

5. On next day, I had given statement to the police regarding person names missed in the complaint, who witness the incident. On same day, police came to the

spot, conducted mahazar. At the time of mahazar, CW.22 and 23 were present and conducted mahazar. At the time of mahazar, photos were taken. I am appearing in the two photographs and showing the place. CW/22 and 23 are also appearing. I had signed the mahazar. Mahazar is marked as Ex.P.4, 4(a) is my signature. Two photographs are marked as Ex.P.5 and 6. The accused is present before the and identifying her.

**Cross Examination: Sri.VGR, Advocate for accused:**

6. I know to write Kannada. Ex.P.3 complaint is written by me in the police station on 13.01.2022.

**Que:** Did you had any impediment to visit the police station on 09.01.2022 and file complaint?

**Ans:** Before filing the complaint, I had requested then MLA Bhopaiah to look into the matter.

7. On 09.01.2022 I met MLA in the evening. Bhopaiah has told me to settle yourself. On 10.01.2022 Bhopaiah has called me and accused and there was altercations and he

told me to settle. I have not stated in the complaint, that on 10.01.2022 there was confrontation between me and accused. It is true that against me Crime No.6/2022 FIR was registered against me. It is not true that CC No.852/2022 case has been registered against me at the instant of accused. I do not know the accused in that case is one of the victim. It is not true that the accused not aware of my caste.

8. The accused is aware of my caste as my wife contested in town panchayath Schedule Caste basis. It is true that the accused was President of Sthayi Samithi, Town Municipality. It is not true that my wife was not liked the accused elected as a President of Sthayi Samithi.

9. I have not handed over the copy of work order to construct the road to the police. It is not true that on 09.01.2022 I was in my private property. I say, I was

doing construction of road. CW.2 to 18 are all belongs to my caste. In Shivakeri voting booth there are 800 voters. No one has recorded video of alleged incident. The video recording mentioned in the complaint not pertained to this incident.

10. It is not true that on 09.01.2022 at 11.30 am the accused did not come to our area. It is not true that the signatures on mahazar was put in the police station. It is not true that the accused was elected as a president of Sthayi Samiti against my wife, as such I had enmity with accused. I had given documents to the police to show that I am belongs to Schedule Caste. It is not true that ಹೊಲೆಯ ಮಾದಿಗರು ನಿಮಗೆ ಏನೂ ಕೆಲಸ ಮಾಡಿಕೊಡಬಾರದು, ನಿಮ್ಮ ಜಾತಿನೇ ಹೀಗೆ and not humiliated in public view. It is not true that police not come to the spot and no mahazar was conducted.
