Examination-in-chief by Public Prosecutor:

1. From 2017 to 2021 I worked in Virajpet Town PS as Head Constable.
2. On 09.01.2021 PW.4 called me and briefed about the information received by him about illegal prosecution in the Coorg Mist Home Stay and asked me and other staffs were assist in the raid. Accordingly, around 3.10 PM Arji Village, to the house of accused No.1. Two witnesses CW.5 and 6

were secured on the way to the spot. We reached at 3.30 PM we noticed three persons were sat on bench, accused No.1 has ran away. Accused No.2 and 3 were present. We enquired accused No.2 about the person ran away from the place, she told is Santhosh her husband.

3. We went to first floor of the building and knocked the door, one person opened the door. He was semi nude, one lady was also in the room, she disclosed her name as Yasmin/PW.2. She was wearing skirt, she was asked to wear the cloths and enquired her. She told that accused No.1 called her stating that he will pay Rs.5,000/- and accused No.3 has brought her in the auto rickshaw from Kushalnagar.
4. She also told she had a sex with Diwakaran and Sujith, who were in the room and she had produced Rs.4,000/- at MO.5, used to condoms at MO.2, unused 8 condoms and Kamasutra one cover at MO.3 and 4. Same were seized under mahazar at Ex.P.2. I have also signed the mahazar. My signature is

marked as **Ex.P.2(d)**. Ex.P.3 photo was also taken at the time of mahazar. Register was also seized under mahazar. Register is marked as **Ex.P.17**. The auto rickshaw was also seized. It belongs to accused No.3. I can identify the auto rickshaw if shown to me. It was stopped in front of the building. The auto rickshaw is also appearing in the photos at Ex.P.10 (series). PW.2 was brought to station and she was left in the Madikeri Women Shelter. Accused No.2 and 3 were also brought to station. Accused No.1 and 3 are present, and identify them. Accused No.2 is absent. I can identify if shown to me, identity is not disputed. I have given statement in this regard.

Cross Examination:Sri.HRS for Sri.KNV Advocate for accused No.1 and 2.

5. It is not true that on 09.01.2021 PW.4 did not called me and not explained about the information and I was not assisted in alleged raid. Coorg Mist Home Stay is situated at a distance of around 3-4 km from Arji main road. There no houses around home stay. The denomination and serial number of

seized currency notes of Rs.4,000/- is not remember. It is not true that PW.5 being Higher Official, to help him deposing falsely before the Court. It is not true that no articles were seized under mahazar. PW.2 was not present in the house of accused No.1.

Cross Examination: Advocate for accused No.3 adopted the cross examination of accused No.1 and 2.

Re- Examination: Nil.
