**Examination-in-chief by Special Public Prosecutor:**

1. From 16.10.2019 to 31.03.2021 I have worked as CPI, Gonikoppa Circle.
  
2. On 11.01.2021 on instruction of PW.4 I had taken additional charge of Virajpet Circle. On same day, I had taken the charge of this case from PW.4.
  
3. I have requested the Court to record 164 Statement of PW.1 to 3. I have received 161 Cr.P.C statement of PW.2 from

WPSI/CW.15, Women Police station, Madikeri on instruction of PW.4. Now I see the statement given by PW.2 at Ex.P.6. I have received Coorg Mist Home stay registration certificate. It is marked as **Ex.P.21, 21(a)** is my signature. On same day, I have received B extract of the vehicle bearing No.KA-12-B-4275 from online. B extract and certificate of fitness of the said vehicle are marked as **Ex.P.22 and 23**. My signatures are **Ex.P.22(a) and 23(a)**. The said vehicle stands in the name of accused No.3. On same day, I have received permit and insurance copy of said auto-rickshaw. The same is marked as **Ex.P.24, 24(a)** is my signature. Pollution certificate is marked as **Ex.P.25, 25(a)** is my signature. I have recorded statement of CW.5 to 7, CW.8 to 12, 16 and PW.8. PW.6 has given statement at Ex.P.18, PW.7 at Ex.P.19. I have received 164 Cr.P.C statement copies of PW.1 to 3 at Ex.P.5, 1, 7.

4. On 13.01.2021 further statement of PW.2 was recorded through PW.5. She has given further statement now I see the same and

marked as **Ex.P.26**. On 17.01.2021 I have handed over case file to CW.19.

**Cross Examination: Sri.KNV Advocate for accused:**

5. It is not true that I have not received 161 Cr.P.C statement of PW.2 from CW.15. It is not true that Ex.P.6 statement has been created for the purpose of the case. It is not true that I have not recorded statements of PW.3 to 7 and CW.8 to 12 and PW.8. It is not true that I have not obtained document pertain to home stay. It is not true that I have not received auto-rickshaw documents. It is true that as per Ex.P.24 permit the auto-rickshaw is permitted to play within 15 kms radius of Mysuru District of Kushalnagar. It is not true that the auto-rickshaw was not seized as it cannot be permitted to come to Virajpet as per the permit. It is not true that the documents are collected for the purpose of the case. It is not true that I have not investigated the case.
