**Examination-in-chief by Public Prosecutor:**

1. From 03.06.2021 to 11.05.2022 I have worked as PDO in Bittangala Gram Panchayath, Virajpet Taluk.
2. On 30.03.2022 the Investigation Officer requested me to provide existance of lane house in the estate of PW.4 Changappa @ Raja. Now I see the requisition marked as **Ex.P.47, 47(a)** is my signature.
3. On 07.04.2022 myself and bill collector visited the estate of PW.4 and found the lane houses consisting of 3 portions.

Accordingly, I have issued certificate. The photo of the lane house is marked as Ex.P.48, 48(a) is my signature. My certificate is marked as Ex.P.49, 49(a) is my signature.

4. On 12.03.2022 the Investigation Officer is also requested me to provide information regarding the lane houses in the estate of Theethamada Muthanna/CW.15. Now I see the requisition marked as Ex.P.50, 50(a) is my signature. On 07.04.2022 on visit to the estate of CW.15, on verification found the lane house accordingly, took photograph and issued a certificate. The photo is marked as Ex.P.51, 51(a) is my signature. The report is marked as Ex.P.52, 52(a) is my signature

5. On 12.03.2022 the Investigation Officer is also sought information about the lane house of PW.9 father estate. The requisition marked as Ex.P.53, 53(a) is my signature. After receipt of requisition on 07.04.2022 visited the estate of PW.9 father and found the lane house, took photograph

and issued a certificate. The photo is marked as Ex.P.54,  
54(a) is my signature. Ex.P.55 is the certificate,  
Ex.P.55(a) is my signature.

**Cross Examination: Sri.KCP standing counsel for accused.**

6. Ex.P.48 photo lane house belongs to Malavanda Changappa. The said lane house was shown to me by Malavanda Changappa. When our visit to lane house, no one was found in the three portions of lane house. Bill collector Machaiah had taken photograph at Ex.P.48. About 10 minutes we have inspected the lane house.
  
7. On same day, we have visited Theethamada Muthanna lane house, which is situated near by Malavanda Changappa's opposite estate. Ex.P.51 is the photograph of lane house of Theethamada Muthanna. At the time of visit to the said lane house, no one was present. It is not true that I did not visit any of the lane houses and created certificate and photos. I have verified the office records regarding payment of taxes to lane house. I have not furnished the

copy of tax paid receipt to Investigation Officer. It is not true that to help the Police I am deposing falsely before the Court.
