Examination-in-chief by Public Prosecutor:

1. PW.1 and 2 are my father and mother. CW.4 is my husband. CW.5 is my sister. Accused is the husband of CW.5.
2. In the year 2023, I was in the house my mother called me and stating that somebody has assaulted her and father. On next day, myself and my husband went to the house of my mother at Kiragooru Village. Police came there and conducted mahazar inside the house of my mother. My mother has shown the scene of occurrence to the police. My signature is

appearing in the mahazar, mahazar is marked as **Ex.P.3, 3(a)** is my signature.

3. I do not know the accused with intention to kill my father in respect of my sister going for work, with the beer bottle and squeezed my mother neck. I have not given statement against the accused. The seven photographs now shown to me at the time of mahazar now shown to me. Seven photos are marked as **Ex.P.4 to 10.**

4. At the time of mahazar, police collected blood stains and sample soil by scraping. My father two blood stained cloths were seized along with pieces of beer bottle. Pieces are beer bottles, blood stained cotton, sample soil cotton, white colour blue stripes shirt and blue and green colour check lungi are marked as **MO.1 to 5** respectively. The same were wrapped in white cloth and sealed separately. The chit containing my signatures were taken in each article. The signatures are

marked as MO.1(a) to 5(a). I have not given statement against the accused.

(At the stage, learned PP seeks to declare witness as hostile, permitted)

Cross Examination: Learned Public Prosecutor:

5. It is not true to suggest that on 26.12.2023 at 6.30 pm myself and my husband were in the house, my mother called me over phone stating that at 6.00 pm the accused came to the house with holding beer bottle in his hand and quarreled with father in respect of CW.5 going for work. It is not true to suggest that my mother has also told that accused No.1 with intention to kill PW.1, beer bottle was made into pieces with that stabbed on right side abdomen, right side back of neck and caused blood injury, when she intervened the accused with hands squeezed her neck, assaulted to her right eye and caused hurt. It is not true to suggest that I have given statement on said facts. The portion of statement is marked as Ex.P.11. It is not true to suggest that I have compromised with the accused and deposing falsely.

Cross Examination: Sri.KKM Advocate for accused submits no cross.

Re- Examination: Nil.
