Examination-in-chief by Public Prosecutor:

1. I know deceased Prakash, PW.1, 2 and accused No.1, who are Mallanda family members. My estate is situated at distance of 200 mtr from the house of accused No.1/Subramani. The Prakash family had property dispute with accused No.1 family.
2. On 30.03.2024 at about 11.30 am I was in my estate and heard firing sound. CW.5 had also called me over phone

from his estate, stating that he had heard firing sound. Immediately, I rushed to near the house of accused No.1/Subramani. When I reached spot, PW.2 was shifting in a car to the hospital. Mallanda Prakash was lying by the side of accused No.1 gate. CW.10 was also present by the side of dead body of Prakash. PW.3, CW.5, CW.9 were inside the car with PW.2.

3. I had drove the vehicle and taken PW.2 to the Gonikoppa Government Hospital for treatment. After dropping PW.2 in the hospital, I went to the house of PW.1 and informed her about the shoot out by accused No.1 with accused No.2 in front of his gate. I had taken PW.1 from her house to the spot. By that time the dead body of Prakash was shifted to the jeep. Thereafter, I was present at the crime scene until completion of spot mahazar.
4. I came to know from PW.2 that accused No.1 with assistance of accused No.2 fired with gun at Prakash and

- Pw.2. Thereafter, Police came to the spot. CW.6 Chodumada Subramani was also present. Police have collected blood stained swab from ground, control swab, blood stain paint scraping from compound wall. Control paint scraping from compound wall and two pellets from the spot. The articles were seized and sealed under mahazar in envelop covers. I signed the mahazar. Now I see the mahazar, is marked as **Ex.P.21, 21(a)** is my signature. I showed the crime scene.
5. Now I see the spot in Ex.P.2, 4 and 5, myself and CW.6 are appearing. The blood stain swab was collected has appearing in Ex.P.2(a) place. Now I see the compound wall from where blood stained paint scraping was collected, appearing in Ex.P.2 and 3 photos. The said portions are marked as **Ex.P.2(c) and 3(b)**.
6. My signatures are appearing on chit pasted on six sealed articles envelop covers. Now I see 1) blood stain swab

collected from ground, 2) Control swab, 3) Suspected blood stained paint chips scrapping collected from compound wall, 4) Control paint chip scrapping collected from compound wall, 5) Pellet-1 and 6) Pellet-1. Same are marked as MO.11 to 16. My signatures are marked as MO.11(a) to 16(a).

7. Now I see the dead body of Mallanda Prakash, appearing in Ex.P.7 to 9. I given statement. At the time of mahazar, the dead body of Prakash was inside the jeep as appearing in Ex.P.4 and 5.

Cross Examination: Advocate for accused Sri.VSP submitted that accused No.1 has hospitalized, no instruction for cross examination. Prayer is rejected (for the same reasons stated separately in the order sheet dated 18.12.2025).
