Examination-in-chief by Public Prosecutor:

1. I know deceased Prakash, PW.1, 2 and accused No.1, who are Mallanda family members and belongs to my village. My estate is situated at a distance 1 1/2 km from the crime scene. There was a property dispute between family of Prakash and accused No.1.
2. On 30.03.2024 myself and CW.7 were proceeding towards Hudikeri in my car. Around 11.35 am PW.2 Dyan called

me over phone stating that ನನ್ನ ದೊಡ್ಡಪ್ಪ ಸುಬ್ರಮಣಿ ನಮ್ಮ ತಂದೆಗೆ ಹಾಗೂ ನನಗೆ ಅವರ ಮನೆಯ ಗೇಟಿನ ಬಳಿ ಶೂಟ್ ಮಾಡಿದ್ದಾರೆ, ಬೇಗ ಬನ್ನಿ ಎಂದು ಹೇಳಿದರು.

Myself and CW.7 immediately rushed to the spot within 5 minutes. Around 200 feet distance from the spot, PW.4, 5 and CW.9 were shifting PW.2 in a car to the hospital. PW.2 told me to attend his father. When I reach the spot, I found two jeeps at the spot. The dead body of Prakash was lying near the gate. Accused No.1 and 2 were standing by the side of dead body of Prakash. Accused No.1 was holding gun in his hand, I had seen the same at the distance of 80 feet.

3. CW.7 pushed me back and caution not to got to the spot as accused No.1 was holding gun. The dead body of Prakash shifted to the jeep by the labours. PW.4 has brought PW.1 to the spot from her house. The police came to the spot and conducted mahazar in my presence and presence of

PW.4. The Police collected MO.11 to 16 from the spot. Now I see the same and identify them. The said articles were sealed in envelop covers and signed on the chit on each cover. My signatures are marked as **MO.11(b) to 16(b)**. I had signed to the mahazar at Ex.P.21, **21(b)** is my signature. Now I see the place, where the dead body of Prakash of lying appearing in Ex.P.2(a) and 3(a) place. Ex.P.6 is also place the blood stain were appearing. In Ex.P.4 and 5 the dead body of Prakash is lying in the jeep. In Ex.P.7 to 9 dead body of Prakash is appearing.

4. The dead body was shifted to Madikeri hospital. The dead body is appearing in Ex.P.10 and 11 in hospital. On 04.04.2023 Gonikoppa Police called me to the police station and issued notice. CW.18 Chinnappa was also present. The blood stained cloth of PW.2 was brought from the Mysuru Hospital and seizer of same notice was issued. It is marked as **Ex.P.23, 23(a)** is my signature.

Pw.2 shirt was shown to me which was blood stained. Now I see the same, it is already marked as MO.2. My signature on chit, is marked as **MO.2(a)** and signature of CW.18 is marked as **Ex.P.2(c)**. Myself and CW.18 signed the mahazar and the mahazar is marked as **Ex.P.24, 24(a)** is my signature and signature of Chinnappa is **Ex.P.24(b)**. I have given statement in this regard.

Cross Examination: Advocate for accused Sri.VSP submitted that accused No.1 has hospitalized, no instruction for cross examination. Prayer is rejected (for the same reasons stated separately in the order sheet dated 18.12.2025).
