**Examination-in-chief by Special Public Prosecutor:**

1. From June 2014 to June 2021, I had worked as PC No.273 in Virajpet Town Police Station.
2. On 21.07.2019, CW 19 called me, PW 2, CW 11, CW 13 and CW 15 to the office and explained about the information received by him stating that the accused No.1 Razak is running prostitution in his rented house, situated at Shanti Nagar, Virajpet, asked us to accompanied him for raid. Accordingly, we reached the rented house of accused No.1 at

1.30 PM. PW 3 Prakash, the owner of the house was present, he was explained about intended search of premises occupied by the accused No.1. The search warrant issued by the IO to PW 3.

3. In presence of Panchas, as well as owner of the house, the first floor door was knocked, one lady opened the door. CW 19 enquired the said lady, she disclosed her name as H.S.Jayanthi @ Rakshita, D/o Satish, R/at Holenarsipur, Hassan. She was enquired in detailed by Investigation Officer, she had stated that she came to house of accused No.1 to collect the amount, at that time accused No.1 and 2 showed her a person and asked to cooperate with said person and they will pay the extra amount. As such the said lady as told that she had undergone sexual intercourse with unknown person and he left the place. She had also disclose that accused No.1 on seeing police ran away from back the door, accused No.2 had gone to Hospital.

4. CW 19 in the said place shown by CW 2, there Mahazar was conducted. Hence, in the said place MO.1 used condom, MO.2 unused condom, MO.3 Kohinoor condom packet were seized under mahazar at Ex.P.2. Now i see MO.1 to 3 seized at the spot. I have given statement. I was present at the time of mahazar but not signed.
5. Now i see Ex.P 3 to 7 Photographs which were taken at the time of mahazar. I am also appearing along with PW 1, 4 and 3.
