Examination-in-chief by Special Public Prosecutor:

1. I know CW.2/Umesh, CW.3/Mahesh, CW.4/Ashok, CW.5/Ravi, CW.6/Pradeep Kumar and CW.7/Pramod Kumar. I do not know the accused No.3 present before the Court.
2. In the year 2022, on Siddapura-Mysuru road, Siddapura at 8.30 pm, myself and CW.2 to 7 were in front of wine shop waiting for labour amount to be paid by the owner. At that time some group of persons were quarreling.

Myself and CW.2 went there, at that time behind me somebody has assaulted me as well as CW.2. Accused No.3 was not present along with accused No.1 and 2, he has not assaulted and threatened to kill us. CW.2 has sustained injury to his hand. He was shifted to Siddapura hospital.

3. Police took my signature, now I see the signature containing in the complaint. Complaint is marked as **Ex.P.2, 2(a)** is my signature. On next day police came to the spot, I had shown the place, police seized beer bottle pieces and blood stained mud and sample mud. My blood stained T-shirt was also seized. Four sealed articles are open before the Court, now I see the beer bottle pieces, blood stained stone pieces, sample stone pieces and one T-shirt. Same are marked as **MO.1 to 4** respectively.

4. Myself and CW.2 belongs to Schedule Caste. I had sustained injury on my left side of head. Now I see the mahazar, marked as Ex.P.3, 3(a) is my signature. Now I see the four photographs taken at the time of mahazar, appearing seizer blood stains, sample stone pieces and cloths. Same are marked as Ex.P.4 to 7. I have given statement regarding mahazar.

(At the stage, learned PP seeks to declare witness as hostile, permitted)

Cross Examination: Learned Special Public Prosecutor:

5. It is not true that on 27.09.2022 accused No.1 at 8.30 pm infront of Prakash wines near tar road, accused No.1 picked up quarrel with us, stating that we were smiled at him, he abused in filthy words by taking caste name, he held my neck with hands, accused No.2 came with two beer bottles, accused No.1 took up beer bottle from accused No.2, broken into pieces, try to stab on abdomen of CW.2, he escaped and hit to his left hand. It

is not true that accused No.2 with beer bottle with intention to kill me assaulted on left of the head. It is not true that accused No.3 with intention to kill threatened. It is not true that I have given complaint against accused No.1 to 3. It is not true that after compromise deposing falsely to help the accused.
