Examination-in-chief by Public Prosecutor:

1. From 2012 to September 2025 I had worked as Medical Officer in Government Hospital, Siddapura.

2. On 27.09.2022 at about 9.10 PM one Aiyappa, S/o Ravi, Aged 36 years, R/at Kolamala was came to hospital along with one Umesh with the history of alleged assault by an unknown adult male while he was sitting inside the jeep, at

Siddapura bar, Pollibetta Road assaulted with a beer bottle on 27.09.2022 at around 9.00 p.m.,

3. On examination following injury was found:

1. Laceration left side temple scalp 3 cm with bleeding.
2. Laceration 0.5 cm above it.

4. The injury is '**Simple**' in nature. I have issued the Wound Certificate at **Ex.P.14**. My signature is marked as **Ex.P.14(a)**.

5. On same day with same history of assault came along with Aiyappa on same time. On examination following injury was found:

1. Scratch abrasion right forefinger base on dorsum 3 cms long.
2. Laceration left thumb pulp 0.5 cm with bleeding present.

6. The injury is 'Simple' in nature. I have issued the Wound Certificate at **Ex.P.15**. My signature is marked as **Ex.P.15(a)**. The wound certificates were issued on requisition of IO. The requisition is marked as **Ex.P.16, 16(a)** is my signature.

7. On 01.10.2022, the PSI of Madikeri Sub-Division had sent injured by name Aiyappa R.M. S/o Late Ravi, aged 36 years to the hospital along with police, requesting to test the blood group of injured and submit a report.

8. On the same day, I tested the blood group of the injured and found that the blood group of injured Aiyappa is 'A' **Positive**. In this regard I have issued out patient slip. Now I identified the requisition marked as **Ex.P.17, Ex.P.17(a)** is my signature. The blood group report is marked as **Ex.P.17(b)**,

Ex.P.17(c) is my signature. The injuries sustained by the injured may be possible with broken beer bottle.

Cross-examination: Advocate of accused is absent. Accused prays time for cross examination and deferred to tomorrow.
