**Examination-in-chief by Spl. Public Prosecutor:**

1. From September 2016 to June 2025 I had worked as Medical Officer in Community Health Center, Kutta.

2. On 13.07.2021 at 11.10 pm, the PC-217 of Kutta Police have brought PW.1 to 4 with history of assault on 13.07.2021 at 4.00 pm. I examined PW.1 Jogi at 11.00 pm. On examination of Jogi, following injuries were found.

1. Tenderness over back
2. Tenderness over left temple

3. Tenderness over chest

3. No external injuries seen. Above mentioned injuries are simple in nature. I have issued the Wound Certificate, Now I identified the wound Certificate issued by me. The wound Certificate is marked as **Ex.P.12 Ex.P.12(a)** is my signature.

4. The injured by name Manju P.M. with the same history of assault. On examination following injuries were noticed.

1. Abrasion over left elbow flexor aspect.
2. Tenderness over left arm
3. Contusion over right Cheek
4. Tenderness over Left Ear.

5. The above mentioned injuries are simple in nature. I have issued the Wound Certificate, Now I identified the

wound Certificate issued by me. The wound Certificate is marked as **Ex.P13, Ex.P.13(a)** is my signature.

6. The injured by name Boji with the same history of assault. Who was brought by WHC-217 On examination following injuries were noticed.

1. Tenderness over left hand
2. Tenderness over Chest
3. Tenderness over head

7. No external injuries seen. The above mentioned injuries are simple in nature. I have issued the Wound Certificate, Now I identified the wound Certificate issued by me. The wound Certificate is marked as **Ex.14, Ex.P.14(a)** is my signature.

8. The injured by name Gowri /PW.4 brought by WHC-217 with the same history of assault. On examination following injuries were noticed.

1. Tenderness over left side of Neck
2. Tenderness over left side of Chest
3. Tenderness over left little finger.

9. No external injuries seen. The above mentioned injuries are simple in nature. I have issued the Wound Certificate, Now I identified the wound Certificate issued by me. The wound Certificate is marked as **Ex.P.15, Ex.P.15(a)** is my signature.

10. The above injuries could be caused by way of man handling.

**Cross-examination: Sri.VSP, Advocate of accused:**

11. In hospital, we will maintain the OPD, emergency and casualty registers. In those registers, the details will be mentioned. It is not true that I have not mentioned the details of history in the MLC register. Since, I have given wound certificates, as such the MLC register extract not furnished. Since, the injured were brought by the Police for treatment, there was no necessity to make correspondence with police regarding the treatment.

12. In the wound certificates casualty register numbers were not mentioned. On request of police, wound certificate were issued. Based on register entries, wound certificates are issued. IO has not collected casualty register extract. In the wound certificates, the name of the persons who assaulted the injured are not mentioned. I say, since police themselves have brought injured as such the names are not mentioned.

13. IO has not collected attendance certificate to show that I was on duty on 13.07.2021. It is not true that I have not treated PW.1 to 4. I have not given separate opinion regarding manner of causing injuries. It is not true that on say on police without examining PW.1 to 4 certificates are issued. It is not true that the injuries mentioned in the wound certificate could be possible in road traffic accident. Apart from wound certificate, no other medical records are given to the police.
