**Examination-in-chief by Spl. Public Prosecutor:**

1. Since 2018 to 2021, I have worked as PSI in Kutta police station.
2. On 13.07.2021 I was on SHO duty, at 9.30 pm PW.1 came to the police station gave a written Ex.P.1 complaint. On receipt of complaint registered the case in Crime No.38/2021 and submitted FIR to the Court and Higher Officials. My signature in the complaint is marked as

**Ex.P.1(b)**, FIR is marked as **Ex.P.18, 18(a)** is my signature.

PW.1 to 4 injured were sent to Kutta Community Health Centre through PC-217 and WHC-217. Further investigation handed over to the CW.14.

**Cross-examination: Sri.VSP, Advocate of accused:**

3. On 12.07.2021 Bannamatte Paisari Ravi has filed complaint against PW.2. In respect of said complaint, I visited Bannamatte Paisari, Nalkeri Village at 4.00 pm. I had inquired the local people. I had enquired Ravi and PW.1 to 4.
4. On 13.07.2021 in respect of this complaint, they came to the police station. In my presence, no incident was took place at 4.00 pm on 13.07.2021.
4. I did not get any information about the incident until filing of complaint. Upto 4.30 on 13.07.2021 I was at Bannamatte Paisari, Nalkeri Village in respect of complaint of Ravi. PW.1 to 4 came to the police station to file

complaint. After registering the complaint, on enquiry with other injured sent to the hospital. I did not reduce into the writing the statements of witnesses. It is not true that I did not sent PW.1 to 4 to the hospital for treatment.

5. The staff has reported me having given treatment to PW.1 to 4. I have not produced documents to show that PW.1 to 4 were sent to the hospital for treatment and they were treated. It is not true that without verifying the facts registered false complaint.
