Examination-in-chief by Public Prosecutor:

1. CW.2 is my son, CW.3 is my husband, I know CW.4 and 5.

My properties are situated at Beguru Village. I am having three acres of land.

2. On 25.07.2021 at about 11:30 a.m., myself, along with CW-2 to CW-5 and three other workers, were working on my estate. At that time, accused numbers 1 to 4 entered my land and quarreled with us, questioning why we were working there, and abused us using the words 'boli magane'. Accused No. 1, armed with a katti, aimed at my neck; when I blocked it with my left hand, I sustained a cut injury on my left hand

3. forearm (the witness is showing her left hand, and the injury mark is visible). Accused No. 2, armed with a dabbe katti, assaulted my son, CW-2 (Muneer), on his head. Accused No. 3, using a wooden club, also assaulted my son, CW-2, on his head. The accused then threatened to kill us if we ever entered the land again.
4. My husband taken me to Government Hospital, Madikeri. Police came to the hospital, recorded my first information statement. I am identifying my statement and marked as **Ex.P.1, 1(a)** is my signature. The accused quarreled with us in respect of landed properties.
5. Accused No.1 is the father-in-law of my son/CW.2. Accused No.2 is the brother of accused No.1. Accused No.3 is the wife of CW.2. Accused No.4 is mother of accused No.2 and 3, all the accused are present before the Court and identifying them.

6. I can identify katti, dabbe katti and wooden club if shown to me. The scene of occurrence is appearing two photographs, shown to me. Same are marked as **Ex.P.2 and 3**. Sealed articles is opened, witness identify katti and marked as **MO.1**. Dabbe katti is also identify and marked as **MO.2**. Wooden club is identified and marked as **MO.3**.
7. I can identify the accused cloths worn at the time of incident. Four sealed articles are opened before the Court, the witness identify blue colour terrycot shirt, pink colour pettycoat, one lungi, one veil, same are marked as **MO.4 to 7** respectively.

Cross Examination: Sri.CKP Advocate for accused:

8. I am residing in Virajpet, alongwith CW.2 and 3. We went to Begur estate. Myself, CW.2 and CW.3 visited the estate. It is true that accused No.3 has filed Criminal case against my son in CC No.538/2021, CC No.591/2021, SC No.5003/2022 and Crl.Misc.No.39/2022, CC No.552/2024, OS No.46/2026 in Virajpet and Ponnampet Courts.

9. I do not know OS No.45/2021 filed by me. I do not know the result of said suit. Accused No.3 is residing with her parents in Chinivada Village. It is false to suggest that, we have threatening the accused to withdraw the case against my son.
10. We left the Virajpet at 11.00 am and visited the Beguru Property at 11.30 am. The quarrel was took place about 15 minutes. We have taken CW.4 to identify the property. We have taken CW.4 thinking that accused may quarreled with us. After filing of number of cases against my son, we have no contact with accused persons.
11. We have informed to police about our visit to property. My son has orally informed to police. Thereafter, my son has brought CW.4 to the spot. The accused suddenly came to the estate and assaulted with MO.1 to 3. It is false to suggest that, intentionally we visited the house of accused at Chinivada and abused in filthy words.

12. It may be true that, the accused have filed case against us in SC No.5003/2022. From the spot, I went to Madikeri Hospital in our vehicle, I do not know its number. On the way to Madikeri Hospital, I have crossed Ponnampet and Gonikoppa police stations, but not informed to them.
13. I have taken 10 days treatment in the hospital. Police recorded my statement. I cannot read Kannada. I do not know the contents of Ex.P.1 as it is in Kannada. The contents are not read over to me. In my statement, I have not stated the survey number and extent of land and the name of the owner is not mentioned.
14. I have not stated special marks to identify to MO.1 to 3 which were used by the accused. MO.1 to 3 are available in the open market. I am not appearing in Ex.P.2 and 3 photographs. The survey number of the land is not mentioned in the said photos. I was wearing MO.4 to 7

cloths at the time of incident. My signature is not appearing on the chit pasted on packing cloths.

15. I do not know who have collected my blood stained cloths. It is false to suggest that, I did not have estate in Begur with intention to threatened the accused persons to withdraw the case, false complaints has be given and deposing falsely. It is false to suggest that, no incident was took place, the accused have not assaulted me and CW.2 and I have not sustained any injuries, MO.1 to 7 are created.
