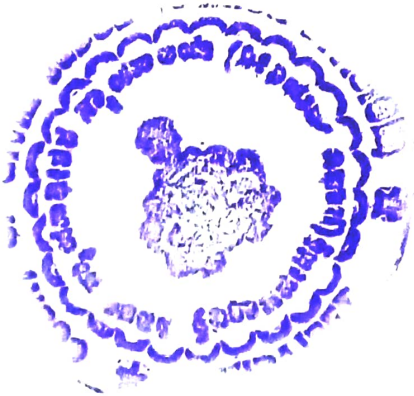
b) Award costs and such other orders.

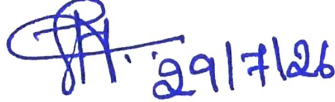
