C H A R G E

I, **Smt B.S.REKHA, B.A.(Law), LLM**, II-Addl. District & Sessions Judge, Kolar, do hereby charge you the accused as follows: -

Since two years there was love affairs between son of CW.1 Venkateshappa namely M.V.Srinatha @ Srinivasa and daughter of accused No.2 Ananthappa and accused No.5 Sumithramma namely Akhila and in this regard, there was ill will between them. That on 18.09.2018 at about 4-30 p.m at Mogilahalli village, within the jurisdiction of Srinivasapura police station, near newly constructed house of CW.1 Venkateshappa and CW.2.Narayanappa, you all the accused persons were being members, formed an unlawful assembly to abuse and assault CW.1 and 2 and thereby committed an offence punishable U/S **143 of IPC** and within my cognizance.

2. On the aforesaid date, time and place, you all accused persons, in furtherance of your common object, intentionally insulted CW.1 and CW.3 and thereby gave provocation to them intending that such provocation would cause the said CW.1 and CW.3 and deceased M.V.Srinatha @ Srinatha to break the public peace and thereby committed an offence punishable U/S **504 r/w.Sec.149 of IPC** and within my cognizance.

3. On the aforesaid date, time and place, you all accused persons in furtherance of your common object, threatened CW.1 and CW.3 and also threatened and abetted M.V.Srinatha @ Srinivasa to commit suicide and that you thereby committed an offence punishable U/S **506 r/w.Sec.149 of IPC** and within my cognizance.

4. On 18.9.2018 at about 4-30 p.m, you accused persons abetted Srinatha @ Srinivasa to commit suicide, due to which on 28.9.2018 at 4.00 p.m., at Mogilahalli village in the Sy.No. 32/2 belongs to Nanjundareddy , said M.V.Srinatha @ Srinivasa was hanged to the tree and thus you accused persons abetted its commission by instigating said M.V.Srinatha @ Srinivasa to commit suicide and thereby committed an offence punishable under **Sec. 306 r/w Sec.149 of IPC** and within my cognizance.

5. On the aforesaid date, time and place, you accused persons not being the members of SC/ST community, intentionally insulted, humiliated and abused CW.1 and 3 deceased M.V.Srinatha @ Srinivasa, who belongs to Scheduled caste in filthy language by touching their caste by saying “ಎನ್ನೋ ಕೀಳು ಜಾತಿ ನನ್ನ ಮಗನೇ ಮಾದಿಗ ಜಾತಿಗೆ ಸೇರಿದ ನಿನಗೆ ...” within the public view knowing fully well that CW 1 and 3 & deceased M.V.Srinatha @ Srinivasa belongs to

Scheduled caste and abetted deceased M.V.Srinatha @ Srinivasa to commit suicide, due to which said deceased hanged to a tree and committed suicide and thereby you accused have committed an offence punishable U/S **3 (1)(r) (S) of SC/ST (POA) Act, 1989**, and within my cognizance.

6. On the aforesaid date, time and place, you accused persons not being the members of SC/ST community, instigated deceased M.V.Srinatha @ Srinivasa to commit suicide and committed the offence which is punishable with imprisonment for a term of ten years or more against a member of Scheduled Caste/deceased M.V.Srinatha @ Srinivasa and thereby committed an offence punishable U/S **3 (2) (v) of SC/ST (POA) Act, 1989**, and within my cognizance.

And I hereby direct you the accused be tried on the above said charges.
