**Further chief examination by Sri.NBR learned counsel
for Petitioner:-**

I have produced the following documents i.e.,

- 1). I have produced the true copy of the FIR and it is marked as ExP1.

2). I have produced the true copy of complaint which is marked as Exp2.

3). I have produced the true copy of the spot mahazar which is marked as Exp3.

4) I have produced the true copy of the further statement of complainant which is marked as Exp4.

5) I have produced the true copy of the IMV report which is marked as Exp5.

6) I have produced the true copy of the wound certificate which is marked as Exp6.

7) I have produced the true copy of the charge sheet which is marked as Exp7.

8) I have produced the discharge summary which is marked as Exp8.

9) I have produced the Original Medical Bills (26 in number) totaling to Rs.2,28,913/- which are collectively marked as Exp9.

10) I have produced the final bill which is marked as Exp10.

11) I have produced the Medical Prescriptions (27 in number) which are collectively marked as Exp11.

Cross-examination by Sri.DVV learned counsel for the respondent No.1: -

I have not produced documents in regard his admission to school. It is false to suggest that my son is not going to

school and therefore I have not produced any documents to the court. It is false to suggest that my husband is addicted to alcohol. It is false to suggest that my husband who had consumed alcohol ridden the two wheeler and due to self fall my son had suffered injuries. I have not produced the insurance copy of our motor cycle. It is false to suggest that I have not incurred medical expenses of Rs.2,28,913/- towards the treatment of my son. It is false to suggest that accident had occurred due to the negligent act of my husband. There is no road hump near the place of accident.

Cross-examination by Sri.KPR learned counsel for the respondent No.2: -

I had not seen the accident. The public have informed me about the accident. I do not know the name of person who had informed me about the accident. The two wheeler belonging to my husband. I have not produced document before the court the two wheeler belonging to my husband. My husband is having driving license, but I have not produced the same to court. It is false to suggest that though my husband had no driving license I am deposing falsely. It is false to suggest that my husband had no driving license hence I have not produced the same to court.

My son is studying 2nd standard. It is false to suggest that as my husband is an alcoholic he has ridden the vehicle in a negligent manner due to his negligent accident had

occurred. The bus came from Chinthamani to Kolar it is vacant bus. I do not know whether the bus had no permit to move from Chinthamani to Kolar. I do not know that the driver of bus had no license to drive the bus and he had license to drive goods vehicle. It is false to suggest that insurance company is not liable to indemnify the claim of claimants. I can produce the license of my husband. It is false to suggest that I have produced false medical bills to claim higher compensation. It is false to suggest that after discharge from the hospital no treatment is taken.
