Examination-in-Chief by learned P.P.:-

Pw-1 Narayanamma is my mother. I know Cw-2, Cw-5 and Cw-6. I know Cw-3, he is no more. I know the accused who is present before the court today. I belong to Adi Karnataka Caste. Accused belongs to Gowda community.

On 23.11.2022, I went to my village Bandahalli to meet my mother. I was at home by 6.00pm. I heard the quarrel sound, I was inside the house and I came out and saw that, the accused was assaulting my mother with the stone on her head and she sustained bleeding injuries and with the same stone, the accused had assaulted my mother on her hand and blood stains fell on her saree. The accused humiliated by touching our caste by saying, “ ಹೊಲೆ ಮಾದಿಗ ಮುಂಡೆ, ನನಗೆ ಬುದ್ದಿ ಹೇಳೋದಕ್ಕೆ ನೀನ್ಯಾರು ”. Cw-2 Aralakunte Narayanappa pacified the quarrel and I took my mother to Government Hospital, Mulbagal.

The witness identifies M.O.1 and M.O.2. I have given statement to the police, when the police had enquired me. The witness identifies the accused who is present before the court today. The quarrel had taken place at around 7.00pm.

For Cross examination Sri.CRK for counsel for accused.

The distance from Karadaguru Village to Bandahalli is around 6 kms. I am married to Karadaguru Village. Karadaguru Village and Kannasandra Village are neighboring village.

It is true to suggest that, Cw-2, Cw-3 and Cw-5 are my relatives. Cw-6 belongs to my community but not my relative.

I used to go often to meet my mother to her village. On the day of the alleged incident, after finishing my work I went to meet my mother in Bandahalli village. There are also other caste people surrounding the house of Pw-1. The distance from the house of Pw-1 to Gangamma temple is 10 feet and Ambedkar statue is around 20 feet. It is a public road. The distance between public road and to the house of accused is half kilometer.

I do not know the reason for the quarrel between Cw-2 Aralakunte Narayanappa and the accused. I was inside the house, after I heard the sound of quarrel and I went out and saw that, the accused was assaulting my mother. When the quarrel took place there were many people.

I do not know the length of quarrel, I was inside the house, after hearing the quarrel sound, I went out side. Before that, I have not seen between whom the quarrel had taken place. I heard my mother was humiliated and abused and hearing that, I came out side of the house. I heard my mother screaming.

The distance between the Ambedkar statue and house of the accused is around 100 feet.

Myself and my mother had earlier filed case against Chalapathi. I had taken my mother to the Hospital. I had given statement to the police on the next day of the alleged incident i.e., 25. I do not know which day it was.

It is true to suggest that, there will be lot of stone fallen around in our village.

It is false to suggest that, I had not come to the house of my mother on the day of the alleged incident.

It is false to suggest that, I was not having knowledge about the incident and my mother had narrated to the same to me.

I had given M.O.1 and M.O.2 to the police. I am working as group “ D” worker in the hospital. I have stated to the police that, I had taken and given the M.O.1 and M.O.2.

It is false to suggest that, at the instance of My mother , I am deposing falsely against accused, in order to harass him.

It is false to suggest that, the accused had never assaulted my mother, nor humiliated by touching our caste.

It is false to suggest that, my mother has an habit of consuming alcohol and after consuming alcohol, she went and fell on the stone and sustained injury and false case has been filed against the accused that, he had assaulted my mother.

Cw-2 Aralakunte Naranayanappa is my uncle. I do now know whether he has an habit of consuming alcohol. I do not know whether there was any money dealing between Cw-2 and the accused.
