Examination-in-Chief by learned P.P.:-

Cw-2 Mohan is my father. Cw-3 Mala is my elder sister. I know Cw-4 to 9, they are from my village. I also know the accused No.1 to 4 present before court today. I belong to Schedule Tribe. Accused No.1 to 4 belongs to Vokkaliga Caste.

On 6.3.2023, at 8.00pm I was near the government school of our village. Myself and one Bharath and one Manjunath were near the government School. The accused No.1 Manjunath and Muniraju was quarreling with each other. I said not to quarrel and I went home. I was sleeping in my

house at around 8.45pm, the accused No.1 Manjunath and accused No.2 Bharath came inside my house and pulled me out of the house and assaulted me with the club. The accused No.1 assaulted with the club on my head and also threatened me with dire consequence. I sustained bleeding injuries and my clothes were blood stained. The accused No.2 Bharath assaulted me with the club on my left shoulder. By the time the accused No.3 Anand and accused No.4 Sridhar came and humiliated taking my caste that “ ನಿನ್ನ ಅಮ್ಮ ಜಾತಿನೇ ಕ್ಯಾಯ, ನನ್ನ ತಂಟೆಗೆ ಬಂದರೆ ಸಾಯಿಸಿಬಿಡುತ್ತೇನೆ ”. The accused No.4 had humiliated taking my caste. The accused No.3 Anand had close the gate and abetted the other accused to assault me. At that time Cw-5 Shashikumar came and pacified and took me to the government hospital, Thoralakki, thereafter I was taken to SNR hospital, Kolar. After I gained conscious, I had given statement complaint to the police in the SNR hospital.

Now I see the Statement complaint which is marked as Ex.P1 and I identify my signature as Ex.P1(a).

I can identify my blood stained clothes and the clubs if shown to me today.

(The learned PP seeks permission to open the seal and same is permitted.)

Now I see my blood stained shirt, which is marked as M.O.1 and blood stained pant as M.O.2 and two Clubs are marked as M.O.3 and 4 respectively.

The witness identifies the accused No.1 to 4 present before the court today.

(The counsel for the accused submits that he shall cross examine the Pw-1 After the chief examination of all the eye witnesses.)
