::ORDER::

Accused No.1 to 3 are present. Case Copies furnished and examined them under section 251 of Cr.P.C. they admitted their guilt for the offence U/sec. 188 of IPC and 127-A of R.P Act and pleaded guilty. I am satisfied that the plea of accused persons voluntary. As such, accused No.1 to 3 are convicted under section 252 Cr.P.C. Accused heard on quantum of sentence. They stated that their entire family are dependant upon their earning and that they are the sole earning member of their family and prayed for mercy of the court. As the plea of the accused persons is voluntary in nature and provisions of P.O. Act cannot be invoked. By considering the submission of accused person, a lenient view is taken upon accused persons and they are sentenced to pay a fine of Rs.200/- each for the offence U/sec. 188 of IPC and further sentenced to pay a fine of Rs.2,000/- each for the offence U/sec.127-A of RP Act. i.e., total fine of Rs.6,600/-. The unmarked case property deposited vide PSL No 74/2024 serial number 2 i.e., seized 750 Pink colour Pakidi rumals shall be destroyed and Serial No.1 which was given to the petitioner/owner of the property vide orders in Crl. MP. No. 564/2024 shall made absolute after the expiry of appeal period if no appeal is preferred. In default of the payment of fine they are sentenced to undergo S.I., for a period of (15) days.
