Examination-in-Chief by learned P.P.:-

Cw-2 and Cw-3 are my elder brothers. I also know the accused No.1 and 2 who are present before the court today. I belong to Adi Dravida Caste. The accused No.1 and 2 belongs to Golla Caste.

Around one year back at 9.30pm the procession of deity Lord Ganesh was going on. At that time I went out of my house to the road(open space) for nature call. The accused No.1 and 2 came there and dragged me inside the Mango Grove. When the accused No.2 held my hand, I bit the hand of accused No.2 Shashikumar and both the accused torn my dress and fisted me on my Jaws, body, hands, legs and all the

parts of my body. I said the accused No.1 and 2 that, I will inform this incident to my husband for which, the accused No.1 and 2 threatened me that, they shall kill my husband. I also said that, I will lodge complaint against them, for which the accused No.1 and 2 threatened me by saying that, they will kill my family by pouring kerosene and further the accused No.1 and 2 abused and humiliated by taking my caste by saying that, “ಏಮೇ ಮಾದಿಗ ಮುಂಡ ನಿನ್ನಿ ನೀ ಮೋಗಿನ್ನಿ ಸಂಪೇಸ್ತಾಮು, (ಏನೇ ಮಾದಿಗ ಮುಂಡೆ, ನಿನ್ನನ್ನು ಮತ್ತು ನಿನ್ನ ಗಂಡನನ್ನು ಸಾಯಿಸುತ್ತೇನೆ)”. Further I bit the hand of the accused and escaped from there. I went and said my husband about the incident. On the same night myself and my husband informed the parents of accused No.1 and 2. After their parents came, the accused persons ran from the spot. On the next day I had lodge the complaint, as there was no bus at that time.

Now I see the complaint which is marked as Ex.P1 and I identify my signature as Ex.P1(a).
