This is a case coming on this day before me for hearing in the presence of **Smt.K.Syamala**, learned Assistant Public Prosecutor for prosecution and upon perusing the material on record, this Court made the following :

COMMITTAL ORDER

The Sub Inspector of Police, Buttaigudem Police Station, filed this case in Crime No.69/2022 of Buttaigudem Police Station alleging that Accused have committed the offence punishable under Sections 498-A, 313, 506 r/w 34 of Indian Penal Code, 1860 (for short, 'I.P.C.') and Section 4 of Dowry Prohibition Act.

2. **The case of the prosecution, in brief, as follows...**

(i). LW.1/Somu Jhansi Lakshmibai is a native of Ramannagudem village, Buttaigudem Mandal. During 2007-2010 while LW.1 was studying B.Com at Vegavaram Engineering College, Jangareddigudem Mandal. Accused No.1 made her to believe that he loves her and he would marry her and he got married LW.1 in 2010 at Araku village, Visakha District. Later Accused No.1 joined LW.1 in BIG-C mobile phones shop at Tenali, for Rs.4500/- per month and he kept her in a room. Accused NO.1 used to stay 15 days with LW.1 and 15 days at Hyderabad, for his coaching six months after, on 10.08.2010, Accused No.1 shifted LW.1 to Rajamahendravaram and got joined her in Universal Mobile shop, for Rs.8500/- per month. After five years, Accused NO.1 got shifted LW.1 to Kukatpalli, Hyderabad, and joined her in Universal Mobile shop, for Rs.13500/- per month and shifted the residence. After five years, LW.1 joined in JIO mobiles shop at Hyderabad, for Rs.18000/- per month and worked there for two months. During her wedlock, LW.1 conceived Accused No.1 threatened LW.1 and got aborted by giving papaya and unknown tablets. Because of LW.1 lost her pregnancy for about four times. 5th time, LW.1 conceived Accused No.1 took her to a doctor for abortion and doctor informed about risk and danger to mother, if done abortion. Then Accused No.1 sent Lw.1 to her parent's house for delivery. After delivery, as Accused NO.1 did not come to LW.1, LW.1 went to her in-laws house Taduvai village along with her child and sare articles. Few days, Accused No.1 stayed with her at Taduvai village and later he went away to Bangalore and there he developed illegal affair with other woman and he directed his parents to harass his wife to bring dowry form her parents. As per the directions of Accused NO.1, A.2 to A.4 together harassed LW.1 both mentally and physically and demanded her to bring Rs.6,00,000/- dowry from her parents and also threatened her with dire consequences. LW.1 gave report to police.

(ii). Basing on the report of LW.1, LW.12/SI registered the case in Cr.No.69 of 2022, under Sections 498-A, 313, 506 r/w 34 of I.P.C and Section 4 of Dowry Prohibition Act and on 05.03.2022 arrested the accused. After completion of investigation, he filed charge sheet.

3. Upon perusal of material placed by L.W.12-SI, this Court took cognizance for the offence under Sections 498-A, 313, 506 r/w 34 of I.P.C and Section 4 of Dowry Prohibition Act against Accused.

4. On appearance of Accused, copies of case papers furnished as contemplated U/Sec.207 of Cr.P.C., and when they were examined, they stated that they got means to engage counsel to defend them before the Hon'ble Court of Sessions.

5. Having heard the learned Assistant Public Prosecutor, and upon perusing the material on record and keeping in view of the fact that as the offence under Section 313 IPC is exclusively triable by a Court of Session, this Court is of the view that it is a fit case to commit the case to the Hon'ble Court of Session, West Godavari Division, Eluru.

6. In the result, the case against Accused Nos.1 to 5 are committed to the Hon'ble Court of Session, West Godavari Division, Eluru U/Sec.209 (a) of Cr.P.C. Accused Nos.1 to 5, who are on bail are ordered to be appeared before the Hon'ble Court of Session as and when summons received, and the Station House Officer, Buttaigudem Police Station is directed to produce Accused Nos.1 to 5 before the Hon'ble Court of Session as and when summons received as provided U/Sec.209 (b) of Cr.P.C. The Office is directed to submit the entire case record along with the property to the Court of Hon'ble Sessions Judge, West Godavari, Eluru U/Sec.209 (c) of Cr.P.C. Notify the committal of the case to the learned Public Prosecutor U/Sec.209 (d) of Cr.P.C.
