ORDER

Heard, L/APP. Perused prosecution paper. Excise Sub-inspector, Mulbagal has filed this charge sheet against accused persons for the offenses punishable U/sec. 32 and 34 of K.E Act. In-spote of providing sufficient time and opportunity, excise police have not secured presence of the accused persons. Process U/sec. 82 and 83 of Cr.P.C. also issued for securing the presence of accused, went in vain. The revenue authorities have submitted report that the accused persons does not own any property. This court has recorded evidence of Pw1 to 5 and got marked Exp1 to 8 and also Mo1. Order sheet discloses that, learned predecessor in office has ordered the office to submit entire records to Hon'ble Prl. Dist and Sessions Judge, Kolar vide order dated. 08.02.2012. Thereafter, entire file returned with direction to trace accused vide letter no. MT.265/2016 dated. 13.01.2016. However, the case file was not called and was traced on 15.05.2018. Since, compliance U/sec. 82 and 83 of Cr.P.C and also completed evidence U/sec. 299 of Cr.P.C, I proceed to pass the following; ORDER Office is directed to submit entire records to the Hon'ble Prl. Dist and Sessions Judge, Kolar seeking permission to transfer this case to long pending cases register (Reg no. XIII).
