

Case taken on today's board as per the advancement application filed by Sri KAR adv for A1 and 3.

A1 and 3 are present.

Sri KAR adv files Vakalath for A1 and 3 along with application U/sec.70(2) of Cr.P.C. along with bail application U/s.439 of Cr.P.C. along with Surety affidavit along with Declaration U/s.441(A) of Cr.P.C. along with RTC extract, attested copy of Aadhaar card of Surety.

Copies served on PP.

Heard both sides on the aforesaid Bail Application.

Perused the records of this case.

Offences alleged against the accused No.1 and 3 are punishable with death or life imprisonment and triable by this Court.

Moreover the Accused No.1 and 3 have obtained Regular Bail in Crl.Misc.No. 702/2021 and 426/2021 as per Orders dated 30.10.2021 and 13.08.2021 passed by this Court.

It is a well settled principle of law that once the Regular Bail is granted to the accused during the pendency of the Criminal Case, the same remains in force till the conclusion of the trial of the Case.

Hence, the following-

**ORDER**

**Bail application filed by the Accused No.1 and 3 U/Sec. 439 of Cr.P.C is hereby allowed.**

**Accused No.1 and 3 are enlarged on bail on they executing personal bond for Rs. 1,00,000/- each with one surety for the like sum to the satisfaction of this Court on the following-**

**CONDITIONS**

**1. Accused No.1 and 3 shall not tamper the prosecution witness nor shall destroy the prosecution evidence in any manner during the trial of this Case.**

**2. Accused No.1 and 3 shall take up the trial of this Case by being present regularly on all the dates of hearing of this case unless exempted by this Court for valid reasons.**

**3. The surety holder shall keep the Accused No.1 and 3 present before this Court on all dates of hearing of this case till the conclusion of trial of this case.**

**4. That in the event of violation of the above conditions by the Accused No.1 and 3 the prosecution is at liberty to seek for cancellation of Bail granted to Accused No.1 and 3.**

Surety by Name- Devendrappa S/o Dodda Earanna @ Earappa is present before the Court and has produced the RTC extract of Sy.No. 22/\*/1 measuring 01 acre 39 guntas situated at Devipura Village in Hirekotnekal Hobali, Tq. Manvi, Dist. Raichur which discloses that he is the owner of the same and the market value of the said property is more

than Rs.20 lakhs per acre as stated in the affidavit.

Enquired and Satisfied with the same.

Surety offered for Accused No.1 and 3 is accepted.

Office to take P/B and S/B of the Accused No.1 and 3 and that of their surety accordingly.

NBW issued against A1 and 3 is hereby recalled.
