Examination in Chief by Learned Public Prosecutor:

1. I do not know CW2. On 20.05.2018, at about 08.00 pm, I had been to Gangavathi Police Station on some other work. Police asked me to come to panchanama. Police have conducted panchanama and took my signature. One person has produced the cloths. Police have seized the same. I do not know who has handed over the said cloths. The cloths were already packed. I have affixed my signature on the chit affixed on the cloth cover. I cannot identify M.O.-4 and 5. Witness identifies his signatures on the chits affixed on cloth covers of M.O.-4 and 5. The same are marked as M.O.-4(a) and 5(a). Police informed me that, there was a galata and they are taking my signatures. I do not know between who the galata has happened. Witness identifies his signature on the cloths seizure mahazar. The cloths seizure mahazar is marked as Ex.P.-2. Witness identifies his signature on Ex.P.-2 and the signature of witness is marked as Ex.P.-2(a).

(At this stage, Public Prosecutor prays for permission to treat this witness hostile. Permission granted.)

Cross-Examination by Learned Public Prosecutor:

2. It is false to suggest that, on 20.05.2018, at about 08.00 am to 09.00 am, Police called me and CW2 for cloths seizure mahazar. It is false to suggest that, CW11 has produced blood stained and torn M.O.-4 and 5 cloths belonging to CW9 and 10. It is false to suggest that, during cloths seizure mahazar, the Police have seized M.O.-4 and 5. It is false to suggest that, after read over the contents of Ex.P.-2 to me, I have affixed my signature. It is false to suggest that, though I am aware about the cloths seizure mahazar, I am deposing falsely before the Court in order to help the accused persons.

Cross-Examination by Sri BNH, Advocate for Accused No.1, 2, 4 and 6 to 9:

Counsel for Accused No.1, 2, 4 and 6 to 9 submits that, he has no cross-examination.

Cross-Examination by Sri MI, Advocate for Accused No.5:

Counsel for Accused No.5 submits that, he has no cross-examination.

Re-examination: Nil.
