C H A R G E

I, Sri Sadananda Nagappa Naik, BAL.,LLB, Addl.,District
and Sessions Judge, Koppal (Sitting at Gangavathi) do hereby
charge you / Accused,

- 1) Accused No.1 by name: Mariyappa S/o Devappa Saloni,
Age: 68 Years, Occ.: Farmer, R/o. Saloni Oni, Karatagi
Taluk and Koppal District.
- 2) Accused No.2 by name: Durugappa S/o Devappa
Ulenoor, Age: 62 Years, Occ.: Farmer, R/o. Karatagi, Now
at Venkateshwar Camp, Sindhanur Taluk and Raichur
District.
- 3) Accused No.3 by name: Devendrappa S/o Mariyappa
Ulenoor, Age: 47 Years, Occ.: Hamali work, R/o. Saloni
Oni, Karatagi Taluk and Koppal District.
- 4) Accused No.4 by name: Basavaraj S/o Mariyappa
Ulenoor, Age: 40 Years, Occ.: Clerk, R/o. Saloni Oni,
Karatagi Taluk and Koppal District.

As follows:

Firstly, on 17.02.2025, at about 07.30 pm, in Sy.No.324
measuring 02 acre 39 guntas of Yaradona seema, when CW1

was working in the field on the basis of lease along with CW4 and 5, you Accused No.1 to 4, in furtherance of your common intention, entered into the field of the CW1 Complainant with an intention of committing offence and committed criminal trespass in the aforesaid field and you thereby committed the offence punishable U/s.329(3) of BNS, 2023 R/w sec.3(5) of BNS, 2023 and within the cognizance of this Court?

Secondly, on the aforesaid said date, time & place, you Accused No.1 to 4, in furtherance of your common intention, you Accused No.1 has assaulted on left shoulder, stomach of CW1 and kicked him on left knee of CW1 and caused bodily pain and you thereby committed the offense punishable U/sec.115(2) of BNS, 2023 R/w sec.3(5) of BNS, 2023 and within the cognizance of this Court?

Thirdly, on the aforesaid said date, time & place, you Accused No.1 to 4, in furtherance of your common intention, intentionally insulted CW1 and thereby gave provocation to him intending that such a provocation would cause him to break the public peace and you thereby committed the offense punishable U/sec.352 of BNS, 2023 R/w sec.3(5) of BNS, 2023 and within the cognizance of this Court?

Fourthly, on the aforesaid said date, time & place, you Accused No.1 to 4 caused a life threat to CW1 with an intent to cause alarm to him and you thereby committed the offense punishable U/sec.351(2) of BNS, 2023 R/w sec.3(5) of BNS, 2023 and within the cognizance of this Court?

Fifthly, on the aforesaid said date, time & place, you

Accused No.1 to 4 being members of non-SC/ST, abused CW1 by referring his caste as “ಲೀ ನಾಯಕ ಜಾತಿಯ ನಾಯಿ ಸೂಳೀ ಮಗನೇ” knowingly well that, CW1 belongs to SC/ST community with intent to insult and humiliate him within public view and thereby you have committed the offenses punishable U/sec.3(1)(r), 3(1)(s), 3(2)(v-a) of Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and within the cognizance of this Court?

And, I hereby direct that you accused be tried by me on the aforesaid charges.
