14. Myself, Hanumesh and Maitri only discussed at Daba. There many leaders in our community at Karatagi. Dalit leaders mentioned in Ex.P.-1 Complaint is related to Moulesh, Durugappa, Hanumesh and Maitri. Dalit women mentioned in Ex.P.-1 Complaint refers to Pushpa, Hanumanthi, Shashikala and Ankitha. It is true to suggest that, Ex.P.-5(a) and (b) videos Moulesh, Durugappa, Hanumesh, Maitri, Pushpa, Hanumanthi, Shashikala and Ankitha are not found. There were more than 20 members apart from us at the alleged spot at the time of the alleged incident. I do not know Kanakappa, Durugappa S/o Katteppa, Venkateshwar Rao S/o Nageshwar Rao. I do not know whether they were present or not present at the time of the alleged incident. It is false to suggest that, the Accused persons are not found at the alleged spot in the videos. It is true to suggest that, I was standing quietly at the time of the alleged incident. I have pacified the incident. It is false to suggest that, in the videos, I am not found pacifying any incident.

15. It is true to suggest that, we are not concerned with

the land of CW7/Kavya in this case. CW7/Kavya is not my relative. I have seen the Dishank App and tried to pacify the incident. I have not seen the documents related to the alleged spot in this case.

16. It is false to suggest that, I am in habit of filing false complaint against others. It is true to suggest that, I am the Accused No.2 in Crime No.101/2025 of Karatagi Police Station for the offences punishable U/sec.31079 of IPC, Accused No.4 in Crime No.135/2025 of Karatagi Police Station for the offences punishable U/sec.307, 354 of IPC, Accused No.1 in CC No.2626/2025 on the file of Addl. Civil Judge and JMFC, Karatagi and Accused No.4 in CC No.2811/2022 on the file Addl. Civil Judge and JMFC, Karatagi for the offences punishable U/sec.341, 269, 270, 283 R/w Sec.149 of IPC. It is true to suggest that, I have also written complaints in Crime Nos.258/2023, 78/2024, 207/2024, 258/2024, 292/2024 and 83/2025 of Karatagi Police Station.

Further cross-examination is deferred for want of time.
