C H A R G E

I, Sri Sadananda Nagappa Naik, BAL.,LLB, Addl.,District and Sessions Judge, Koppal (Sitting at Gangavathi) do hereby charge you / Accused,

Jadiyappa S/o Devappa Mukkundi, Aged: 40 Years, Occ.: Agriculturist, R/o. Navali Village, Kanakagiri Taluk and Koppal District.

As follows:

Firstly, on 14.02.2024, at 10.30 am, near Ambedkar circle of Navali village, you Accused intercepted the Motorcycle of CW1 and wrongfully restrained CW1 and you thereby committed the offence punishable U/s.341 of I.P.C., and within the cognizance of this Court?

Secondly, on the aforesaid said date, time & place, you Accused has assaulted on forehead, left hand palm and back of the CW1 with your right hand and caused bodily pain and you thereby committed the offense punishable U/sec.323 of

I.P.C., and within the cognizance of this Court?

Thirdly, on the aforesaid date, time and place, you Accused intentionally insulted CW1 by stating "ಬೊಸೂಡಿ ಮಗನೇ" and thereby gave provocation to him intending that such a provocation would cause him to break the public peace and you thereby committed the offense punishable U/sec.504 of I.P.C., and within the cognizance of this Court?

Fourthly, on the aforesaid date, time and place, you Accused gave life threat to CW1 by stating that, "ನಿನ್ನನು ಸುಮ್ಮನೆ ಬಿಡುವುದಿಲ್ಲ, ನಿನ್ನ ಕೊಲೆ ಮಾಡದೇ ಬಿಡುವುದಿಲ್ಲಲೇ ಮಗನೇ" with an intent to cause alarm to him and you thereby committed the offense punishable U/sec.506 of I.P.C., and within the cognizance of this Court?

Fifthly, on the aforesaid said date, time & place, you Accused being member of non-SC/ST, abused CW1 knowingly well that, CW1 belongs to SC/ST community with intent to insult and humiliate him within public view and and thereby you have committed the offenses punishable U/sec.3(1)(r), 3(1)(s), 3(2)(v-a) of Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and

within the cognizance of this Court?

And, I hereby direct that you accused be tried by me on the aforesaid charges.
