C H A R G E

I, Sri Sadananda Nagappa Naik, BAL.,LLB, Addl.,District
and Sessions Judge, Koppal (Sitting at Gangavathi) do hereby
charge you / Accused,

- 1) Shakshavali S/o Abdul Rasid, Age: 57 Years, Occ:
Labourer, R/o. Siddapur of Karatagi Taluk, Koppal
District.
- 2) Syameed S/o Moulasab @ Meesi Moulasab, Age: 32
Years, Occ: Agriculturist, R/o. Siddapur of Karatagi Taluk,
Koppal District.
- 3) Pampapathi Madivala S/o Hanumanthappa Mativala,
Age: 45 Years, Occ: Laundry work, R/o. Siddapur of
Karatagi Taluk, Koppal District.

As follows:

Firstly, on 21.06.2023, at about 02.00 pm, at vacant
land, adjacent to BG Auto Electrical Shop, near Raichur road,
Suzuki show room, Gangavathi, when the CW1 and 2 came
out of the Suzuki show room and were standing at the vacant
land, you Accused No.1 to 3 in furtherance of your common

intention, pushed CW1, you Accused No.1 gave fisted blow on right jaw of CW1, you Accused No.2 gave a fisted blow on the waist of the CW1, you Accused No.3 has kicked on stomach and testicles of CW1 and caused bodily pain and you thereby committed the offense punishable U/sec.323 R/w sec.34 of I.P.C., and within the cognizance of this Court?

Secondly, on the aforesaid date, time and place, you Accused No.1 to 3, in furtherance of your common intention, intentionally insulted CW-1 by stating " ಲೇ ನಾಯಕ ಸೂಳೇ ಮಗನೇ ನಾವು ಎಷ್ಟು ಹೇಳಿದರೂ ನಿನಗೆ ಬುದ್ಧಿ ಬರುವುದಿಲ್ಲ, ಏನಲೇ ಸೂಳೇ ಮಗನೇ" and thereby gave provocation to him intending that such a provocation would cause him to break the public peace and you thereby committed the offense punishable U/sec.504 R/w sec.34 of I.P.C., and within the cognizance of this Court?

Thirdly, on the aforesaid date, time and place, you Accused No.1 to 3, in furtherance of your common intention, you Accused No.1 to 3 gave a life threat to CW-1 by stating that, "ನಿನಗೆ ಮತ್ತು ನಿನ್ನ ಹೆಂಡತಿ-ಮಕ್ಕಳಿಗೆ ಬೆಳಕು ಹರಿಯುವುದರೊಳಗಾಗಿ ನಿಮಗೆ ಗುಂಡಿ ತೋಡಿ ಮುಚ್ಚಿ ಬಿಡುತ್ತೇವೆ" and "ನಿನ್ನನ್ನು ಜೀವ ಸಹಿತ ಬಿಡುವುದಿಲ್ಲ" with an intent to cause alarm to him and you thereby committed the

offense punishable U/sec.506 R/w sec.34 of I.P.C., and within the cognizance of this Court?

Fourthly, on the aforesaid date, time and place, you Accused No.1 to 3, being members of non-SC/ST, you Accused No.1 to 3 abused CW1 by referring his caste as “ಲೇ ನಾಯಕ ಸೂಳೀ ಮಗನೇ” knowingly well that, CW1 belongs to SC/ST community with intent to insult and humiliate them within public view and and thereby you have committed the offenses punishable U/sec.3(1)(r), 3(1)(s), 3(2)(v-a) of Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and within the cognizance of this Court?

And, I hereby direct that you accused be tried by me on the aforesaid charges.
