**CHARGE**

I, **Smt. Nirmala.K. B.A, M.L, IV Addl. District & Sessions Judge & C/c V Addl. District & Sessions Judge, Mandya**, do hereby charge you;

1. Shankarnayaka – **(SPLIT UP)**
2. Rajesh.H.M. S/o Late Chikka-mayigowda, Aged about 33 years, R/o T.M.Hosuru Village, Srirangapatna Taluk, Mandya District.

as follows:

That on 18.07.2017 at about 5.45 p.m., when CW1 was driving his loading dust tipper lorry bearing No.KA-09-B-9861 and came near the land of Devaraju of Gananguru Village, situated at V.C.Nala bund, within the limits of Srirangapatna Police Station, you A2 along with accused No.1 awrongfully restrained CW1 from proceeding further by stopping A1's Tractor bearing No.KA-55-T-0842 and thereby committed an offence punishable under section 341 r/w 34 of IPC, and within the cognizance of this Court.

2. Secondly, that on the above said date, time and place, you A2 along with A1 quarreled with CW1 intentionally insulted CW1 by abusing him in filthy language and provoked him intending that such provocation will cause him to break the public peace, and thereby committed an offence punishable under section 504 r/w 34 of IPC, and within the cognizance of this Court.

3. Thirdly, that on the above said date, time and place, in furtherance of common intention A1 assaulted CW1 with hand on the left ear and right ear and caused simple injuries and thereby committed an offence punishable under section 323 r/w 34 of IPC, and within the cognizance of this Court.

4. Fourthly, that on the above said date, time and place, infurtherance of common intention accused No.1 assaulted CW1 with hand on the left ear of CW1 and caused grievous hurt on grave and sudden provocation, and thereby committed an offence punishable under section 325 r/w 34 of IPC, and within the cognizance of this Court.

5. Lastly, that on the above said date, time and place, in furtherance of common intention, you A2 along with A1 not being members of SC & ST Community and knowingly well that CW1 belong to Scheduled Caste, intentionally insulted and abused him by raising his caste name within public view and thereby committed an offence punishable under section 3(1)(s) of SC & ST (POA), Amendment Act, 2015 and within the cognizance of this Court.

And, I hereby direct that you be tried by this Court for the above said charge.
