**CHARGE**

I, **Manjula Itty, C/c** V Addl. District & Sessions Judge, Mandya, hereby charge you accused,

Ravi H.G.,  
Aged about 34 years,  
S/o Late. Giriyappa,  
R/o 1<sup>st</sup> Main Road,  
Halahalli, Mandya city.

as follows:

*Firstly*, that you, Accused-Ravi H.G., on 20.12.2024 at 3.30 PM, the accused not being a member of any Scheduled Caste or Scheduled Tribe Community with the knowledge that CW1 belongs to Scheduled Caste Adi Karnataka Community, trespassed into the vacant site belonging to CW1 situated at Khatha No.911/911, 2<sup>nd</sup> Cross, Halahalli Extension, Mandya city and removed the board placed in the said site depicting that, entry to the said vacant site is prohibited as there were civil suit pending with respect to the said property and thereby committed an offence punishable under section 329(3) of Bharatiya Nyaya Sanhita and under section 3(1)(g) of Scheduled Caste & Scheduled Tribe (Prevention of Atrocities) Act and within the cognizance of this Court.

*Lastly*, that you the above named accused on the above date, time and place, with the knowledge that CW1 belongs to Scheduled Caste Adi Karnataka Community, abused him in filthy and derogatory language raising his caste name by saying “ಹೊಲೆಯ ನನ್ನ ಮಗನೆ, ಸೂಳೇ ಮಗನೆ ನೀನು ಹೊಲೆಯ ಆಗಿರುವುದಕ್ಕೆ ನಿನ್ನ ಸೈಟ್ ಮಾರಾಟ ಮಡುತ್ತಿದ್ದೇನೆ” with an intention to provoke CW1 and to humiliate him and thereby committed an offence punishable under section 352 of Bharatiya Nyaya Sanhita and under section 3(1)(r) and 3(1)(s) of Scheduled Caste & Scheduled Tribe (Prevention of Atrocities) Act and within the cognizance of this Court.

And I hereby direct that you be tried by me on the aforesaid charge.
