COMMITTAL ORDER AS PER SECTION 232 B.N.S.S.

The accused is produced before me from jail through Video Conferencing facility. The Accused is charged with the offence punishable under section 132,125, 352, 351(3) of The Bharatiya Nyaya Sanhita, 2023. In view of coming into force of the B.N.S.,the corresponding Section **132** of Bharatiya Nyaya Sanhita, 2023 is Section 353 of the I.P.C.. The offence punishable under Section **132** of the Bharatiya Nyaya Sanhita, 2023 though shows it as triable by Judicial Magistrate, First Class, but in view of the G.R. of Govt. Of Maharashtra, dated 07th June 2018 the offence under Section 353 I.P.C. is made exclusively triable by the Court of Session. Till the date, the said G.R. is not withdrawn by the Government and is still in force. Therefore, though the said section is shown triable by the Judicial Magistrate, First Class, in view of the G.R. of 2018, it is triable by the Court of Session.

2. The copies of police report and other documents as specified in section 230 of the Bharatiya Nagrik Suraksha Sanhita,2023 have been supplied to the accused. The accused is represented by Lawyer. The case

will have to be committed to the Hon'ble Court of Session. Hence, the order :-

ORDER

1. The case be committed to the Hon'ble Court of Session.
2. The accused is directed to appear before the Hon'ble Court of Session on **20/01/2025**.
3. Accused is remanded to Magisterial Custody until commitment of the case and also during and until the conclusion of trial before the Hon'ble Court of Sessions vide section 232 of the Bharatiya Nagrik Suraksha Sanhita, 2023.
4. The Jail Authority is directed to produce the accused before the Hon'ble Court of Sessions, Gr. Bombay on **20/01/2025**.
5. The record of the case, the documents and articles, which are to be produced in evidence, shall be sent to the Hon'ble Court of Sessions.
6. The Police Station Officer, Police Station Khar be directed to produce muddemal property in the Hon'ble Court of Session on or before **20/01/2025**.
7. The Public Prosecutor shall be notified of the commitment of the case to the Hon'ble Court of Session.
