CHARGE

I, **Manjula Itty**, C/c V Addl. District & Sessions Judge, Mandya, hereby charge you accused,

Aged about 30 years,

S/o: Late. Jogigowda,

3. Karuna G.R.,
Aged about 30 years,
S/o: Ravi G.L.,

Aged about 28 years,
S/o: Lokesha,

All are R/o: Goravanahalli village,
Kasaba Hobli, Maddur Taluk,
Mandya District.

as follows:

Firstly, that you, **A1**-Mahesha G.P., **A2**-Sachin @ Kappe, **A3**-Karuna G.R and **A4**-Lankesha L. not being the members of any Scheduled Caste or Scheduled Tribe Community, with the knowledge that CW1 belong to Scheduled Caste *Adi Karnataka* Community on 19.03.2025 at 8.00 p.m., while CW1 and CW2 were attending nature call in a vacant land in Sy.No.71/1 in Channasandra

village, you-A1 and A2 followed him by a motorbike and you-A1 abused CW1 and CW2 in filthy language raising their caste name and later, in the coconut garden of one G.C. Shivappa in the outskirts of Channasandra village, you- A3 and A4 abused CW1 in filthy language raising his caste name, you-A1 abused CW3 in filthy language and thereby you-A1 to A4 have committed an offence punishable u/s 352 R/w Sec.3(5) of Bharatiya Nyaya Sanhita and offence punishable U/Secs.3(1)(r) and 3(1)(s) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act and within the cognizance of this *Court of Sessions/Special Court*.

Secondly, on the above said date, time and places, you the above named A1 to A4 in furtherance of your common intention, you-A1 and A2 intercepted CW1 and after assaulting him, took him in your motorbike to the coconut and arecanut garden belonging to G.C. Shivappa situated in outskirts of Channasandra village and you -A1 to A4 did not allow him to proceed further and thereby you-A1 to A4 have committed an offence of wrongful restraint punishable u/sec.127(2) R/w Sec.3(5) of Bharatiya Nyaya Sanhita and within the cognizance of this *Court of Sessions/Special Court*.

Thirdly, on the above said date, time and places, you the above named A1 to A4 in furtherance of your common intention to commit murder of CW1, you-A1 assaulted

CW1 with a machete aiming at his head and since CW1 dodged with his hands, the machete hit on his right hand causing hurt to his right palm and forearm and thereby you-A1 to A4 have committed an offence of attempting to commit murder punishable u/sec.109(1) R/w Sec.3(5) of Bharatiya Nyaya Sanhita and offence punishable U/Secs.3(2)(v) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act and within the cognizance of this *Court of Sessions/Special Court*.

Fourthly, that on the above said date, time and places, you the above named A1 to A4 in furtherance of your common intention, you-A1 hit CW2 with the machete on his right hand causing hurt and you-A2 assaulted CW1 with your hands all over his body and when CW2 intercepted them to rescue CW1, you-A3 hit CW1 on his head and all over his body with your hands and you-A4 hit CW1 with the petiole of coconut tree leaf (ತೆಂಗಿನ ಗೊದಮೊಟ್ಟೆ) all over the body of CW1 and you-A1 hit CW3 with the flat surface of the machete on his stomach and left thigh and thereby you-A1 to A4 have committed offences punishable under sections 115(2) and 118(1) R/w Sec.3(5) of Bharatiya Nyaya Sanhita and offence punishable U/Secs.3(2)(va) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act and within the cognizance of this *Court of Sessions/Special Court*.

Lastly, that on the above said date, time and places, you the above named A1 to A4 in furtherance of your common intention, when CW1 raised hue and cry, you-A1 and A2 threatened him that they would kill him there itself and then you-A1 kept the machete on the neck of CW1 and took him by his motorbike bearing No.KA-11-EV-4330 by making him to sit in between A1 and A2 and took him to the coconut garden of one G.C. Shivappa in the outskirts of Channasandra village and you- A4 threatened CW1 that, if he disclosed this to anyone else, he and his family would be killed by setting them ablaze by pouring petrol and thereby you-A1 to A4 have committed an offence punishable u/s 351(3) R/w Sec.3(5) of Bharatiya Nyaya Sanhita and within the cognizance of this Court of Sessions/Special Court.

And I hereby direct that you be tried by me on the aforesaid charge.

Certified that the above charge is read over to accused in language which is known to them and they have understood the contents of the same.

on 19.03.2025 at 8.00 p.m., while CW1 and CW2 were attending nature call in a vacant property in Sy.No.71/1 in Channasandra village, you-A1 and A2 came by a motorbike and you-A1 abused CW1 in filthy language raising his caste name and with an intention to commit murder of CW1, you-A1 assaulted CW1 with a machete aiming at his head and since CW1 stopped with his hands, the machete hit on his right hand and causing hurt to his right palm and forearm and when CW1 raised hue and cry, you-A1 and A2 threatened him that they would kill him there itself and you-A2 assaulted CW1 with his hands all over his body. When CW2 intercepted them to rescue CW1, you-A1 abused CW1 in filthy language and hit with the machete on his right hand causing hurt and then A1 kept the machete on the neck of CW1 and took him by his motorbike bearing No.KA-11-EV-4330 by making him to sit in between A1 and A2 and took him to the coconut garden of one G.C. Shivappa in the outskirts of Channasandra village and called A3 and A4 to the spot and then A3 and A4 abused CW1 in filthy language and A3 hit CW1 on his head and all over his body with his hands and A4 hit CW1 with the petiole of coconut tree leaf (ತೆಂಗಿನ ಗೊದಮೊಟ್ಟೆ) all over the body of CW1 and threatened him that, if he disclosed this to anyone else, he and his family would be killed by ablazing them by pouring petrol. On hearing the hue and cry of CW1, CW3 came to the spot and took the videograph of the accused persons assaulting CW1 through his mobile phone, then A1 abused CW3 in filthy language and hit CW3 with the flat surface of the machete on his stomach and left thigh.
