CHARGE

I, **Smt. Nirmala.K. B.A, M.L, IV Addl. District & Sessions Judge & C/c V Addl. District & Sessions Judge, Mandya**, do hereby charge you;

Taranatha D s/o Dasappa Shetty, aged 39
years, r/o Kikkeri town & hobli, K.R. Pete
taluk,

as follows:

That due to the reason of cancellation of Free health check up programme which was about to be held on 18.01.2023, you accused on behalf of Indian TV on 17.01.2023 during afternoon hours keeping the fact in mind spoke in singular language regarding K.S.Prabhakar, Political leader for which Cw1 had been to Kikkeri police station to lodge complaint against accused for which you accused keeping the said grudge in mind at about 7:15 p.m. when Cw1 had been near Kikkeri milk dairy, started abusing him in filthy language and provoked him intending that such provocation will cause him to break the public peace, and thereby committed an offence punishable under section 504 IPC, and within the cognizance of this Court.

2. Secondly, that on the above said date, time and place, you accused had assaulted with your hands over the face of Cw1 and

assaulted with your legs on the stomach of Cw1 causing him simple injuries and voluntarily hurt Cw1 and thereby committed an offence punishable under section 323 IPC, and within the cognizance of this Court.

3. Thirdly, that on the above said date, time and place, you accused gave life threat to Cw1 by threatening him to taking away his life with intent to cause alarm to him to do an act, which you were not legally bound to do, and thereby committed an offence of criminal intimidation punishable under section 506 IPC, and within the cognizance of this Court.

4. Lastly, that on the above said date, time and place, you accused persons have picked up quarrel with Cw1 and you accused not being member of SC & ST Community and knowingly well that CW1 belong to Scheduled Caste, intentionally insulted and abused him by raising their caste name and humiliated them within public view and thereby committed an offence punishable under section 3(1)(r)(s) of SC & ST (POA), Amendment Act, 2015 and within the cognizance of this Court.

And, I hereby direct that you be tried by this Court for the above said charge.
