CHARGE

I, Smt. B.G.Ramaa, Prl. District & Sessions Judge,
Mandya, hereby charge you;

- A-1. Chikkanna S/o Late Javaregowda, aged
about 55 years, R/at
Puttegowdanadoddi Village, Maddur
Taluk, Mandya District.
- A-2. Basavaraju P.P. S/o Puttanna, aged
about 36 years, R/at
Puttegowdanadoddi Village, Maddur
Taluk, Mandya District.
- A-3. Nataraju S/o Puttanna, aged about 33
years, R/at R/at Puttegowdanadoddi
Village, Maddur Taluk, Mandya District.
- A-4. Darshan S/o Basavaraju, R/at
Puttegowdanadoddi Village, Maddur
Taluk, Mandya District.

as hereunder:-

1. That on 23.03.2021 at about 10.00 p.m., you accused
Nos.1 to 4 along with the Juvenile in Conflict with law

formulated unlawful assembly and in furtherance of common intention came near the residential house of CW-2 Puttamadegowda situated by the side of Honnanaykanahalli-Puttegowdanadoddi-H.Hosur road at Puttegowdanadoddi Village and thereby you have committed an offence punishable U/Sec.143 R/w Sec.149 of I.P.C. and within my cognizance.

2. That on above said date, time and place you accused Nos.1 to 4 along with Juvenile in Conflict in furtherance of common intention, committed the offence of rioting by holding deadly weapons and thereby you have committed an offence punishable U/Sec.148 R/w Sec. 149 of I.P.C. and within my cognizance.

3. That on above said date, time and place you accused Nos.1 to 4 along with Juvenile in Conflict with law in furtherance of common intention insulted C.W.2 Puttamadegowda by abusing him in filthy language and thereby gave provocation to him intending that such provocation would cause him to break public peace and thereby committed an offence punishable under Section 504 R/w Sec.149 of I.P.C. and within my cognizance.

4. That on above said date, time and place you accused Nos.1 to 4 along with Juvenile in Conflict with law in furtherance of common intention, of which you accused No.3 assaulted C.W.2 with a repara patti on his head, you accused

No.2 assaulted CW-2 with a Axe on his head with such intention or knowledge and under such circumstances that had the act of yours caused death of C.W.2, you would have been guilty of murder and thereby committed an offence punishable U/Sec. 307 R/w Sec.149 of I.P.C. and within my cognizance.

5. That on above said date, time and place you accused Nos.1 to 4 along with Juvenile in Conflict with law in furtherence of common intention, of which you accused No.1 assaulted C.W.2 on his left hand thumb with a reaper patti caused bleeding injuries to him and thereby committed an offence punishable U/Sec.324 R/w. Sec. 149 of I.P.C. and within my cognizance.

6. That on above said date, time and place you accused Nos.1 to 4 along with Juvenile in Conflict with Law in furtherence of common intention, when CW-2 fell on the ground treaded him with legs and caused bodily pain and thereby committed an offence punishable U/Sec. 323 R/w 149 of I.P.C. and within my cognizance.

7. That on above said date, time and place you accused Nos.1 to 4 along with Juvenile in Conflict with Law in furtherence of common intention, of which you accused No.3 assaulted CW-3 Shobha on her back with a reaper patti which is an instrument if you used likely to cause death or injury, on her person and voluntarily caused her grievous

injuries and thereby committed an offence punishable U/Sec. 326 R/w 149 of I.P.C. and within my cognizance.

And I hereby direct you to be tried by this court on the aforesaid charges.
