I, **Smt.Nirmala.K. B.A, M.L, IV Addl. District & Sessions Judge**, do hereby charge you;

1. Somashekar @ Soma s/o
Hombegowda, aged 25 years, r/o
Huskuru village, Kasaba hobli,
Malavalli taluk,

2. Shivakumar s/o Channegowda,
aged 23 years, r/o Huchegowdana
Doddi village, Halaguru hobli,
Malavalli taluk, Mandya

3. Chandan A.M s/o Markunnaiah,
aged 19 years, r/o Appajaiahnadoddi
village, Halaguru hobli, Malavalli
taluk, Mandya district.

as follows;

That on 19.11.2020 at 10:30 p.m. in front of property
of Kunna Marigowda at Bosegowdana Doddi village,
Malavalli taluk, on Malavalli- Muttanahalli road, when
Cw1 was driving Ashok Leyland Dostgoods vehicle No.KA-
09/D-6927 from Dyavapattana loading gobi (ಎಲೆಕ್ಟ್ರೋಸು) to go

to Mandya market coming from Malavalli side at the same time, you Accused No.1 to 3 took the vehicle Honda Dio scooter bearing Reg.No.KA-11/EM-5899 belongs to Cw11, in which Accused No.2 & 3 were pillion riders ridden by Accused No.1 with an intention to do robbery went backside of the Dostgoods vehicle No.KA-09/D-6927 which is driven by Cw1. Further Accused No.2 hit the backside of the Dostgoods vehicle with a long by giving him signal to stop the vehicle and when Cw1 did not stop the vehicle, you Accused No.2 again hit the front side door of vehicle with long to stop it, thus Cw1 stopped the vehicle due to fear. Then accused No.3 got down from the scooter and took the key from Cw1 by showing knife. Then Accused No.3 pulled Cw1 down from the Dostgoods vehicle and threatened him by keeping the knife over his neck and pickpocket Rs.4,000/- along with purse from Cw1. Further Accused No.2 also cross-checked the pocket of Cw1 and took Vivo company mobile worth Rs.8,000/-, thereby committed the offence of robbery punishable u/sec.392 r/w sec.34 IPC.

Secondly, on the above said date, time and place, you Accused No.3 tried to assault Cw1 with the knife. Then Cw1 tried to escape/ avoid from the knife by bringing his right hand, but anyhow the knife hit to his right hand and caused him simple injuries. Thus, accused No.3 committed robbery of Rs.4,000/- and Accused No.2 also cross-checked the pocket of Cw1 and took Vivo company mobile

worth Rs.8,000/-. Thus, Accused No.3 had caused grievous hurt to cw1 with knife and thereby committed an offences punishable under Section 397 r/w sec.34 of IPC and within the cognizance of this Court.

Thirdly, on the above said date, time and place, you Accused No.1 to 3 went away in the scooter bearing Reg.No.KA-11/EM-5899 by throwing mobile, long and knife into the Mudukutore Kaveri river and hence, you have erased/ destroyed the evidence and thereby committed an offence punishable under section 201 r/w sec.34 of IPC, and within my cognizance.

Lastly, on the above said date, time and place, you accused No.1 driven the scooter bearing Reg.no.KA-11/EM-5899 belongs to Cw11, in which Accused No.2 & 3 were pillion riders, hence, Accused No.1 driven the vehicle without having any licence or permit, thereby committed an offence punishable under section 3 r/w sec.181 of IMV Act?

And, I hereby direct that, you be tried by this Court for the above said charges.
