Vide **Order No. 438/RG/DHC/2021 dated 22.07.2021**, it has been directed that ***with effect from 24.07.2021 all the judicial officers shall endeavour to take up all the matters of their respective courts through videoconferencing and that the physical hearings in the District Courts in Delhi may be resumed in a restricted manner w.e.f.***

16.08.2021 on an experimental basis, subject to further orders based on evaluation of the situation of the pandemic in the NCT of Delhi.

This case is at the stage of arguments on sentence.

Proceedings in this case have been stayed by Hon'ble Delhi High Court in CrI. Rev. P. 419/2018 & CrI. M.A. 9210/2018.

Advocate Anmol Sethi, counsel for the accused persons has informed the court that matter in the Hon'ble High Court is fixed for 24.09.2021 and the interim order is continued.

Rev. Petition No. 419/2020 titled Anand Kumar Singhal Vs. CBI* listed before Hon'ble High Court has been adjourned *enbloc* to 24.09.2021 and interim order is to continue.
