The Applicant above named most respectfully submits as under:-

- 1) That, Applicant / Accused was arrested by Pimpri Police Station on 24/12/2016 in their C. R. No. 725/2016 registered u/s. 376 of IPC and u/s. 5 (j), (2), 6 of Protection of Children from Sexual Offences Act, 2012 and produced before Hon'ble Special Court Pune and remanded to PCR from time to time. Thereafter the Applicant / Accused was produced before this Hon'ble Court and remanded to MCR.

- 2) That as per the case of prosecution the Complainant namely Sujit Satpal Shille has lodged FIR alleging therein that, Accused Vikram Lamba came for stay at the house of Complainant for his work purpose. It is further alleged that, during January, 2016 till March, 2016, when the family members used to sleep in night that time the Accused kept physical relationship with the minor daughter of the Complainant viz. Daya Shille, aged 15 years. Due to which the victim became pregnant and she gave birth to one child. On these set of facts the Complainant has lodged FIR against the Accused on 22/12/2016.
- 3) That Applicant / Accused has not committed any offence but he has have been falsely implicated and hence the Applicant approaching this Hon'ble Court for his release on bail on following among other grounds:-

GROUND

- a) That the Applicant is innocent and he has not committed any alleged offence.
- b) That there is love affair between the Applicant and the victim the Complainant is not agreed for the said relationship.
- c) That age of the Applicant is more than 15 years and she is on the verge of majority.
- d) That the Applicant is ready to marry with the victim, after she attained the age of majority.
- e) That there is no any criminal antecedents against the present Applicant to connect him with the alleged crime.
- f) That investigation of present crime is practically over.

- g) That the release of Applicant / Accused will not cause any hurdle in smooth progress of investigation.
- h) That punishment contemplated for alleged offences is not for life or death imprisonment.
- i) That there is no any criminal antecedents against the Applicant.
- j) That the Applicant is earning member of his family and family members are totally dependent upon the Applicant for their livelihood.
- k) That it will take innumerable time to decide the matter on merit.
- l) That the Applicant is ready to abide by terms and conditions which will impose by this Hon'ble Court.
- m) That the Applicant is permanent residence of the above said address and hence if he released on bail he will not abscond and be available for trial.
- n) That if Applicant will release on bail he undertakes that he will not tamper or tamper the prosecution witness / evidence.
- 4) This is the first bail application filed u/s. 439 of Cr.P.C. and no any other bail application pending or dispose off u/s. 439 of Cr.P.C. in any other court.

- a) The present Applicant may kindly be released on bail on appropriate conditions.
