APPLICATION FOR GRANT OF LEGAL HEIRSHIP CERTIFICATE
UNDER SECTION 7 OF BOMBAY REGULATION ACT.

FINAL ORDER BELOW EXH.1

(Passed on 07.08.2026)

The applicants, named above, have moved this application

under section 7 of Bombay Regulation Act for grant of legal heirship certificate in her name.

2. The case of the applicants, in short, is that:-

The applicant No. 1 is the wife, applicant No. 2 is the son and applicant Nos. 3 and 4 are daughters of the deceased Sevakram Lekhumal Parwani. Deceased Sevakram Lekhumal Parwani, who died on 09.07.2023, at Grace Hospital, Kalewadi, Pune. Deceased Sevakram Lekhumal Parwani was permanent resident of Pune within the jurisdiction of this Court, hence this Court has jurisdiction to try and decide the application. After his death, deceased Sevakram Lekhumal Parwani has left behind him the present applicants as his legal heirs. Besides applicants, there is no other legal heir of deceased Sevakram Lekhumal Parwani. The applicants being the legal heirs of deceased Sevakram Lekhumal Parwani, is entitled for their legal heirship certificate. The applicants are in need of legal heirship certificate for official purpose.

3. In view of this application, due publication was made in the local newspaper i.e. "Prabhat" is filed at Exh.06. The report of publication is uploaded. So also, the newspaper is also uploaded. Present application is supported by an affidavit. Apart from this, the applicant have also uploaded the original copies death certificates of deceased Sevakram Lekhumal Parwani vide Exh. 11, original copies of applicants Aadhar cards vide Exh.12 respectively. All the documents probabibilises the claim of applicants that they are the only legal heirs of deceased Sevakram Lekhumal Parwani. Apart from this, no one has claimed to be the legal heir of deceased Sevakram Lekhumal Parwani

after publication of public notice in the concerned newspaper. The applicant No. 2 has also examined himself vide Exh. 10 to support their case. The applicant No. 2 has deposed in line with the main application. The applicants have uploaded their evidence closing pursis at Exh.13. Hence, I do not find any reason to reject the claim of applicant. Accordingly, I pass the following order:-

ORDER

1. The application Exh.1 is allowed.
2. Issue heirship certificate in the name of applicants namely Mrs. Sheela Sevakram Parwani, Mr. Sanjay Sevakram Parwani, Ms. Geeta Sevakram Parwani, Ms. Komal Sevakram Parwani, being legal heir of deceased Sevakram Lekhumal Parwani.
3. The writ or certificate be issued on payment of requisite stamp duty.
4. Case is closed.
