

**State Vs. Jatin Salwan**

On the last date of hearing, a direction had been given to the jail authorities to get the accused checked from Dental Department Govt. Hospital, Sector 25, Chandigarh as accused Narinder Singh was having acute pain in his wisdom tooth.

In compliance of the said order, accused Narinder Singh has been got checked from the Govt. Hospital Sector 25, Chandigarh from where he has been prescribed certain medicines. Learned counsel for the accused has intimated the Court that jail authorities have not allowed the accused to take the medicines inside the jail and as such he is depending upon the medicines which are being provided to him by the jail authorities. However, those medicines are not sufficient to control the pain and the inflammation and as such he be allowed to take the medicines prescribed by Govt. Hospital Sector 25, Chandigarh. In view of the request made by learned counsel for the accused, Superintendent of Modal Jail Burail Chandigarh is directed to allow the accused to take those medicines which have been prescribed by the doctors of Govt. Hospital, Sector 25,

Chandigarh. Prescription slip be also produced before Superintendent Modal Jail Burail.

Today cross-examination of constable Varinder has been completed. No other PW is present. Bailable warrants of PW Sukhbir Singh Shergill have not been issued by the concerned Ahlmad. She has been directed to be careful in future failing with action would be initiated against her. and now his fresh bailable warrants of arrest be issued and the same be got executed through SHO concerned for 23.7.2018. Remaining witnesses be also summoned for the next date.

Learned counsel for accused Narinder Singh has further pointed out that on 31.5.2018, a direction had been given to the jail authorities to take the accused before Debt Recovery Tribunal-III at Chandigarh in order to attend the matter **titled as DSL Rice Mills Vs. Punjab and Sind Bank** but inadvertently the date of the said hearing had not been incorporated in the Zimni order and as such in compliance of the said order, the jail authorities be directed to produce the accused before DRT Chandigarh tomorrow as the said matter is fixed for tomorrow. In view of the request made by learned counsel for the accused, jail authorities are directed to produce him before DRT at Chandigarh tomorrow in safe custody and then take him back to the jail after completion of the hearing in the said matter.
