JUDGMENT

The plaintiff by name Vikas.R.B S/o Bhagavan.R.B. has filed suit by his natural mother as guardian of minor of plaintiff. The plaintiff has filed the suit against defendants to modify the date of birth of plaintiff in his academic records as "01.03.2005" instead of "04.03.2005" and issue directions accordingly and for such other relief.

2. Brief facts of the case as contended by the plaintiff in the plaint are as follows:

It is the case of the plaintiff that, plaintiff was born on 01.03.2005 at Chinakurali Primary Health Care Center, Pandavapura Taluk and is currently pursuing his first year B.Com degree at Thathaguni Jyothy Institute of Commerce and Management College, Bangalore. Further that, plaintiff had studied from 1st to 10th standard in defendant No.1

school and at the time of his admission to the said school his date of birth was wrongly given as 04.03.2005 and his father 's name was mentioned as Bhaghvan instead of Bhaghvan.R.B. Further that, in all his academic records same is carry forwarded. Further that, in his birth certificate the date of birth was wrongly mentioned as 04.03.2006 and after filing a suit before this court bearing OS.No.04/2021, the got rectified the date of birth as 01.03.2005 and obtained the birth certificate. Further that, after obtaining the said birth certificate he approached defendants to carry out the said correction in his academic records based on the decree obtained by the court and the rectified birth certificate. But, the defendants authorities, did not carry out the correction, but insisted for an order from the court. Thus, plaintiff has filed present case seeking direction to direct the defendants to change the date of birth as 01.03.2005 in his academic records maintained by them.

3. After service of summons, Learned AGP filed memo of appearance for defendants. The defendants have not filed Written Statement in the suit, hence the Written statement of Defendants are taken as Nil. Hence, the case is posted for plaintiff evidence.

4. Plaintiff by name Sri.Vikas.R.B got examined himself as PW-1 and got marked Ex.P-1 to Ex.P.14 documents.

5. Heard the arguments.

6. The points arise for my consideration are as follows:-

POINTS

- 1 Whether plaintiff is entitled for the relief as sought for in the plaint ?
- 2 What order or decree?

7. My findings to the above said points are as follows

Point No.1 : In the Affirmative
Point No.2 : As per final order

REASONS

8. **POINT No.1:-** It is contented by the plaintiff that, earlier he had filed a suit seeking an order directing the competent authorities to include date of birth in the birth certificate and to issue birth certificate accordingly, he also got the birth certificate from the appropriate authority. Further that, after obtaining the birth certificate he approached the defendant authorities to carry out the same correction in the academic records pertaining to plaintiff maintained by them. But, they failed to carry out

the same and sought for direction from the court, hence the suit.

9. Plaintiff has examined as PW.1 and he has filed his affidavit in lieu of his examination in chief, reiterating the averments as stated in the plaint. PW-1 deposed that, Vikas.R.B is born on “01.03.2005” at Chinakurali, Primary Health center, Pandavapura Taluk. The actual and true date of birth of the plaintiff is as “01.03.2005” but in his academic records it is mentioned as 04.03.2005. He has produced Ex.P.1 birth certificate. Ex.P.2 is the earlier birth certificate issued by the competent authority and Ex.P.3 and 4 are Judgment and decree in OS.No.4/2021 these documents shows that, PW.1 earlier had filed the suit seeking for direction to issue birth certificate. He has produced Ex.P.1 it is the rectified birth certificate issued by the competent authority wherein the date of birth is mentioned as 01.03.2005 and his father name is mentioned as Bhagavan.R.B. These documents corroborates the case of the plaintiff.

10. PW.1 has produced Ex.P.5 the letter issued by the BEO calling for the direction from the court. PW.1 has produced Ex.P.6 which is the document to show that, plaintiff was studying in Image English School in the year-2020-2021 and Ex.P.8 is the Transfer Certificate issued by

the said School. PW.1 has produced Ex.P.7, 9 and 10 marks card issued by the Karnataka Secondary Examination Board and Department of Pre-University Education wherein his date of birth is mentioned as 04.03.2005 and his father name is mentioned as Bhagavan. PW.1 has produced Ex.P.11 is the ID card issued by Jyothy Institute of Commerce and Management wherein father name is mentioned as Bhagavan.R.B. PW.1 has produced Ex.P.12 and 13 are the alticket issued by Bangalore University to show that, presently he is studying in Jyothy Institute of Commerce and Management. These documents corroborate of the plaintiff.

11. In the case on hand defendants though have appeared before the court, have to failed to file their Written Statement. The case of the plaintiff is left unchallenged. The present case is filed by plaintiff seeking order of the court to direct defendants to correct the date of birth as 01.03.2005 in the place 04.03.2005 and also to correct his father name as Bhagavan.R.B in the place of Bhagavan. As defendants have not filed a Written Statement no hardship would be caused to the defendants and documents produced before the court corroborates the case of the plaintiff and his case is left unchallenged. Further, the document marked at Ex.P.5 also shows that, defendant authority has sought for an order from the

court. Hence, the plaintiff has established his case and he is entitled for the relief as sought. Hence, this court **answered Point No.1 in the Affirmative.**

12. POINT No.2:- As discussed above, this court proceed to pass the following:-

ORDER

Suit of the plaintiff is hereby decreed.

Defendants are hereby directed to change the date of birth of Vikas.R.B S/o Bhagavan.R.B and Smt.Asha is as **“01.03.2005”** in the place of **“04.03.2005”** and further directed to change his father's name as Bhagavan.R.B instead of Bhagavan in the academic records of the plaintiff maintained by the defendant authorities.

No order as to cost.

Draw decree accordingly.
