**ORDER OF COMMITTAL UNDER SEC.232 OF BNSS-2023, (OLD
SEC. 209 OF CrPC)**

The PSI of Arakere Police Station has filed a charge-sheet against the accused for the offence punishable U/Sec. 352, 109, 118, 351(2) of BNS-2023.



2. The accused is present and they are represented by Sri CSV Advocate.

3. The accused is enlarged on regular bail vide order-sheet dated 24.03.2026 as per the order of the Hon'ble III Addl.District and Sessions Court, Mandya sitting at Srirangapatna in CrI.Misc.No.5146/2025 dated 03.05.2025.

4. Cognizance was taken for the offence punishable U/Sec.352, 109, 118, 351(2) of BNS-2023, vide order – sheet dated:10.11.2025 and ordered to be registered as Criminal Case.

5. The copies of all the prosecution papers have been supplied to accused and complied the provision of Sec.230 of BNSS-2023 (Old Sec.207 of CrPC)

6. Heard both the side on the question of committal and perused the charge sheet.

7. The offences alleged against the accused are punishable U/Sec.352, 109, 118, 351(2) of BNS-2023. U/Sec. 109 of BNS which is exclusively triable by Hon'ble III Addl. District and Sessions Court, Mandya (Sitting at Srirangapatna). There are sufficient materials to commit the case to the Hon'ble III Addl. District and Sessions Court, Mandya (Sitting at Srirangapatna), for trial. Hence, I proceed to pass the following:

ORDER

Acting U/Sec.232 of BNSS - 2023 (Old U/Sec. 209 of CrPC)
this case is committed to Hon'ble III Addl. District and Sessions Court, Mandya (Sitting at Srirangapatna), for trial.



The accused shall appear before the Hon'ble III Addl. District and Sessions Court, Mandya (Sitting at Srirangapatna) soon after the receipt of notice or summons.

To ensure their appearance before the Hon'ble III Addl. District and Sessions Court, Mandya (Sitting at Srirangapatna), the accused shall execute personal bond for Rs.1,00,000/- with one surety for like sum.

Office is directed to notify the Learned Public Prosecutor, Hon'ble III Addl. District and Sessions Court, Mandya (Sitting at Srirangapatna) about the committal of this case.

Office is directed to submit the entire record along with properties to the Hon'ble III Addl. District and Sessions Court, Mandya (Sitting at Srirangapatna) forthwith.
