**COMMITTAL ORDERS U/SEC. 209 OF CR.P.C.**

The Complainant Geologist Mandya has filed complaint under section 200 of Cr.P.C against the accused No.1 and 2 for the offence punishable under sections 4(1), 4(1-A), 21 of MMDR Act 1957 and Sec.3(1), 42(1), 44 of KMMCR 1994. Sec.3, 4 and 16

Karnataka Regulation of Stone Crusher Act 2011. Sec.3, 3A, 3B, 3C. The cognizance was taken by the court for the aforesaid offences against the accused No.1 and 2.

2. The accused No.1 and 2 were enlarged on bail granted by Hon'ble Principal District and Sessions Judge Mandya, in **Crl.Misc.No.440/2020 dated:27.07.2020**. Thereafter he was enlarged on regular bail by this court by an order dated:13.08.2020.

3. The copies of the prosecution materials are furnished to the accused No.1 and 2 in compliance of Sec.207 of Cr.P.C. The accused No.1 and 2 have also furnished surety for their appearance before the Hon'ble Court of Sessions.

4. The alleged offence against the accused No.1 and 2 are under **sections 4(1), 4(1-A), 21 of MMDR Act 1957 and Sec.3(1), 42(1), 44 of KMMCR 1994**. Sec.3, 4 and 16 Karnataka Regulation of Stone Crusher Act 2011. Sec.3, 3A, 3B, 3C., which is exclusively triable by the Hon'ble Court of Sessions. Thus under the powers conferred upon this court under section 209 of Cr.P.C, this court proceeds to pass the following:
