ORDER BELOW EXH. 1.

This is an application for grant of Heirship Certificate under Bombay Regulation VIII of, 1827.

2] It is the contention of applicants that applicant Nos. 1 & 2 are sisters of Nilima Mahadev Butala & Mohan Mahadev Butala. Nilima Mahadev Butala died on 14/11/1988 & Mohan Mahadev Butala died on 07/07/2010 at Navi peth, Mahad. They were unmarried. The parents of applicant Nos. 1 & 2 and deceased Nilima Mahadev Butala & Mohan Mahadev Butala namely Mahadev Krushna Butala died on 07/12/1977 & Indumati Mahadev Butala died on 29/07/1996. The deceased Nilima Mahadev Butala & Mohan Mahadev Butala, were originally resident of Mahad, Taluka – Mahad, District- Raigad. The applicants are only surviving legal heirs of the deceased Nilima Mahadev Butala & Mohan Mahadev Butala. The applicants needs Heirship Certificate for Government and other purposes. Hence, they filed present application.

3] Applicant No.1 filed her affidavit in lieu of examination in chief (Exh.11). In support of their claim, the applicants filed verified copy of death certificate (Exh.4/1) of

Shubhangi Sanjay Parekh nee Shubhangi Mahadev Butala & 1 V/s. Nil

Nilima Mahadev Butala, verified copy of death certificate (Exh.4/2) of Mohan Mahadev Butala, verified copy of death certificate (Exh.4/3) of Mahadev Krushna Butala, verified copy of death certificate (Exh.4/4) of Indumati Mahadev Butala, verified copy of Adhar card (Exh.4/5) of the applicant Nos.1 & 2, Citation (Exh.8) and paper publication (Exh.10/1) in daily newspaper "Dainik Sagar" dated 12/10/2022.

4] From the perusal of records, it appears that nobody appeared and resisted the claims of applicants. Hence, as the application remained unresisted, I have no hesitation to grant a legal heirs certificate in favour of the applicant. Nos.1 & 2 being legal heirs of the deceased Nilima Mahadev Butala & Mohan Mahadev Butala,. Hence, I pass following order.

1. Application is allowed.
2. Issue Heirship Certificate in the name of Sau. Shubhangi Sanjay Parekh nee Shubhangi Mahadev Butala & Sau. Shital Shekhar Butala nee Sunanda Mahadev Butala being legal heirs of the deceased Nilima Mahadev Butala & Mohan Mahadev Butala, as per rules.
