JUDGMENT

Accused are present before the Court. They stated that they wanted to plead guilty to the offence and requested for taking lenient view. Learned APP is present and submitted that considering the nature of offence appropriate order may be passed. Considering the nature of the offence and voluntarily pleading guilty by the accused, I found that following sentence would be sufficient to meet out the ends of justice. Hence, order.

ORDER

1 The accused 1. **Govind Baburao Mane** and 2. **Ganesh Govind Mane** are hereby convicted U/Sec. 252 of the Code of Criminal Procedure, 1973 for the offences punishable U/Sec. 188 of Indian Penal Code.

2 They are sentenced to pay a fine of Rs.1,000/- (Rupees One Thousand only) in default of payment of fine amount they shall suffer S. I. for 3 (three) days, for the offence punishable under section 188 of I.P.C.

3 The accused are also convicted U/Sec. 252 of the Code of Criminal Procedure, 1973 for the offences punishable U/Sec. 269 of I.P.C.

4 They are sentenced to pay a fine of Rs.1,000/- (Rupees One Thousand only) in default of payment of fine amount they shall suffer S. I. for 3 (three) days, for the offence punishable under section U/Sec. 269 of I.P.C.

5 The accused are also convicted U/Sec. 252 of the Code of Criminal Procedure, 1973 for the offences punishable U/Sec. 51 (B) of the National Disaster Management Act.

6 They are sentenced to pay a fine of Rs.1,000/- (Rupees One Thousand only) in default of payment of fine amount <sup>each</sup> they shall suffer S. I. for 3 (three) days, for the offence punishable under section U/Sec. 51 (B) of the National Disaster Management Act.

5 Their bail bond stands cancelled.
