EXAMINATION IN CHIEF BY PUBLIC PROSECUTOR :

I had been police constable at Hebbal Police station between 2018 to 2022.

On 3.10.2021, I was on night duty at 9.15 p.m. CW50 Smt. Ambamma, then PSI deployed myself and CW41 Mehboob Dalal to go to House no.877, 2nd Floor, 2nd Cross, 1st Stage, Hebbal. Accordingly, I had been to said place with CW41. I found dead body of women by name Nanjamma. UDR no.11/2021 already registered. CW41 and myself shifted the dead body from the spot to K.R.Hospital, Mysuru in private ambulance at 11.55 p.m. I handed over the dead body at the hospital and took the acknowledgement from the hospital and submitted the same before CW50. I gave

statement on 4.10.2021 before CW51 Prasad, P.I, Hebbal Police Station.

I can identify the dead body. ExP3 to 7 are the photos of dead body.

CROSS EXAMINATION BY THE ADVOCATE SRI.N.N.R FOR ACCUSED :

On 3.10.2021 I returned to police station at 9.15 p.m. and reported to duty before SHO. I have not stated before IO that I reported to duty at 9.15 p.m. after affixing the signature at SHO diary. It is false to state that CW50 did not present at the station. CW50 deployed me in writing for duty but I did not state same at the statement. I left station at 9.15 p.m. and reached the spot at about 10.15 p.m. The spot is 1.5 k.m. far from the police station. The time of leaving and reaching the spot have not been stated at the statement. I have not carried identification documents of spot since I was conversant to the spot since I was the beat police. It is false to state that I cannot identify the spot.

I had been to spot on my motor cycle. The private ambulance came to the spot at 11 p.m. The said ambulance was called by the SHO. I do not know registered number of said ambulance. I reached the K.R.Hospital at 11.40 p.m. I have not stated the same at my statement.

It is false to say that CW50 has not deployed me and I have not discharged any kind of duty in this case. It is false to say that I deposed falsely.
